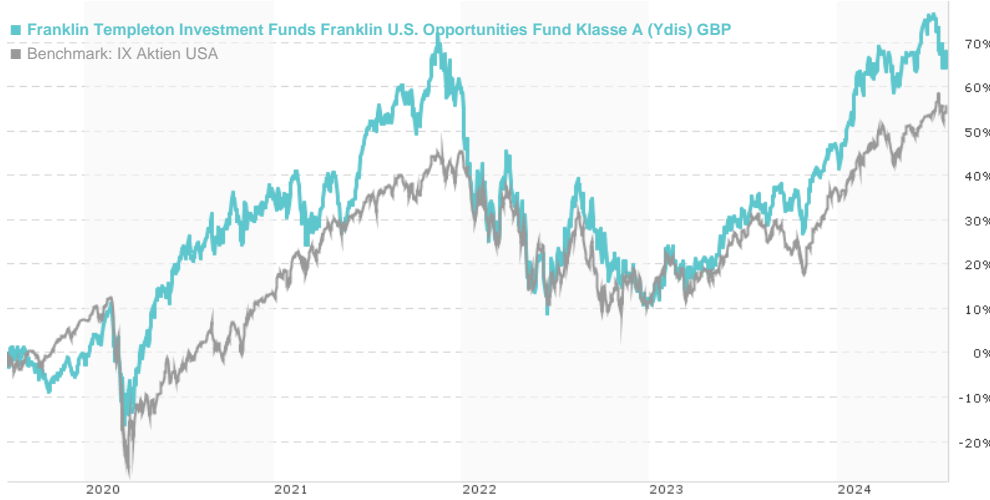

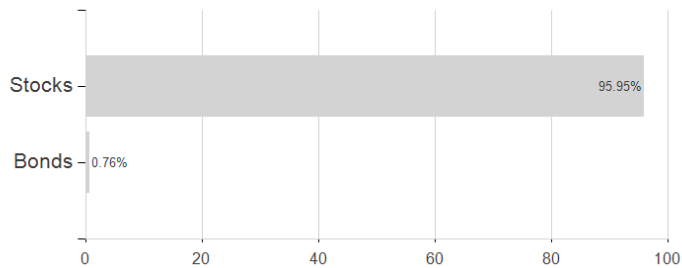

Investment goal

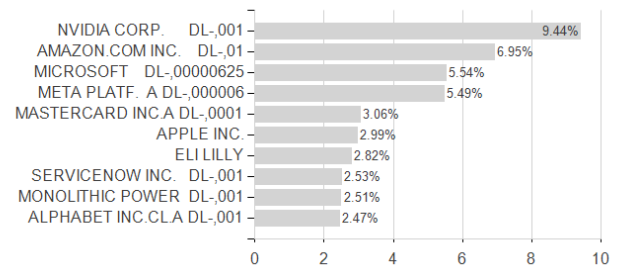

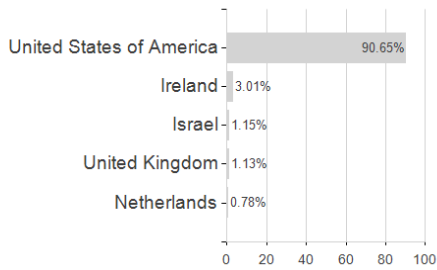

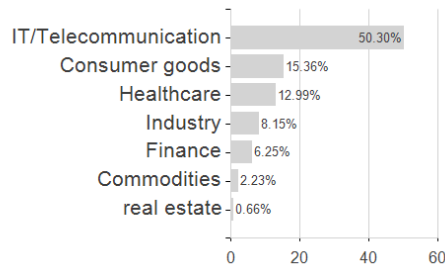
