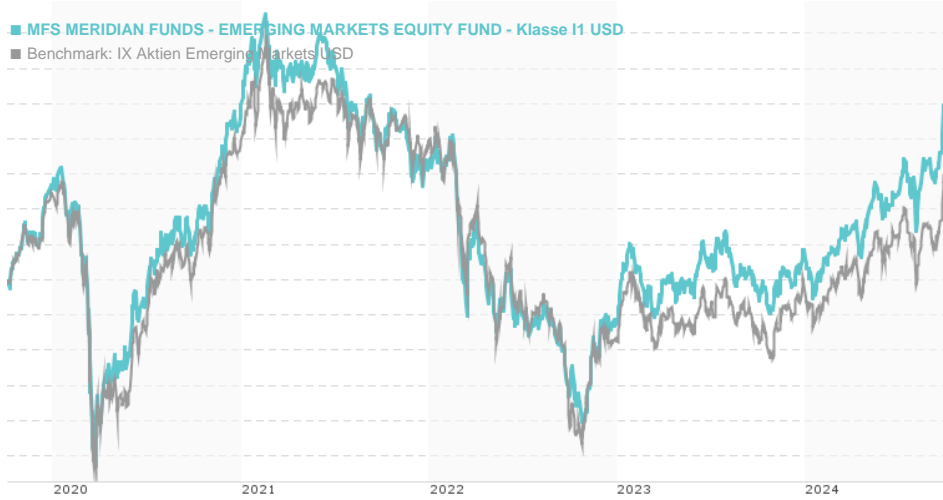

**Investment strategy**

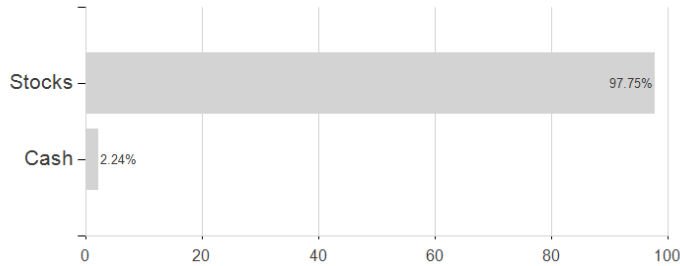

**Investment goal**

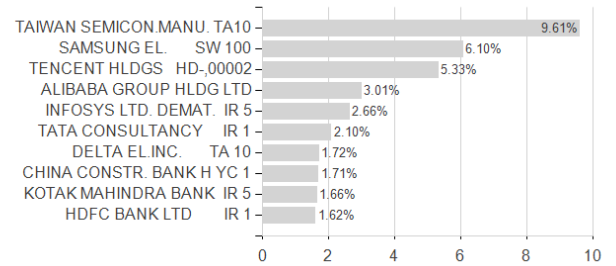
The fund's objective is capital appreciation, measured in U.S. dollars.

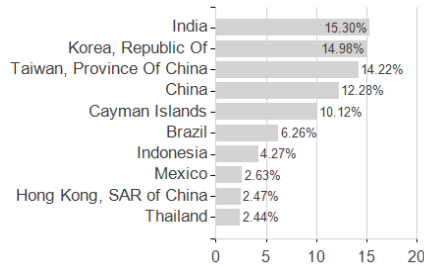

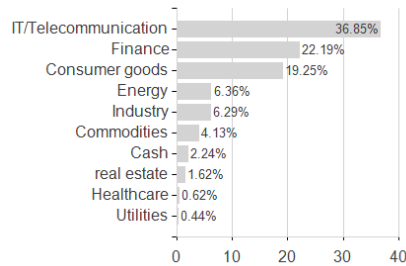
