Investment strategy

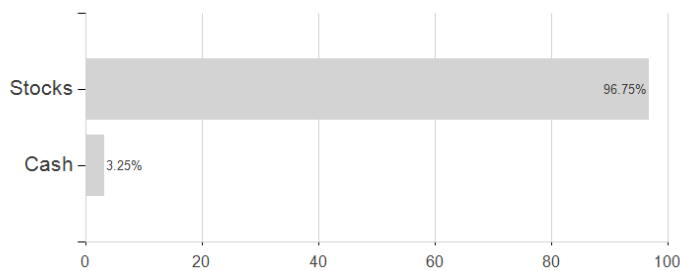

The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. Investment goal

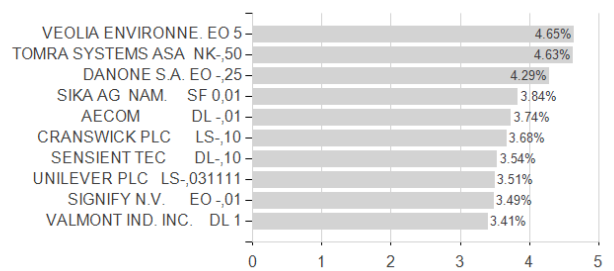

Assessment Structure

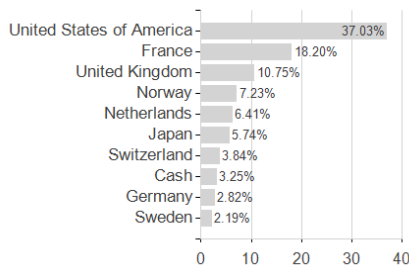

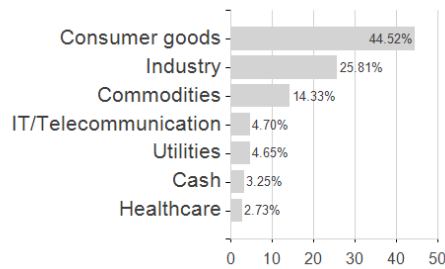
