**Investment strategy**

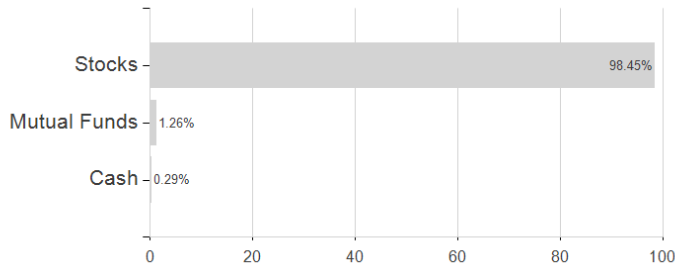

**Investment goal**

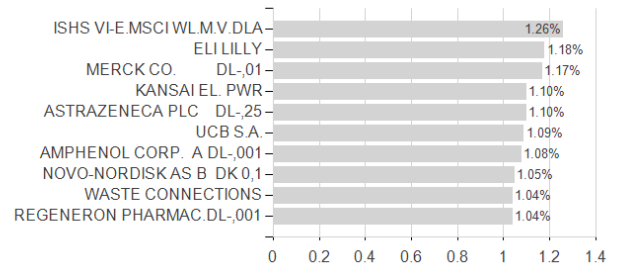
The fund aims to achieve capital growth over the long term, while seeking to maintain a volatility profile that is lower than that of its investment universe.

**Assessment Structure**

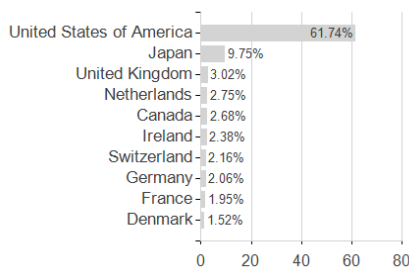

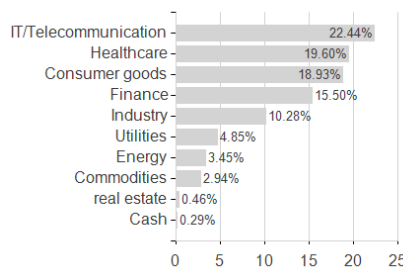
