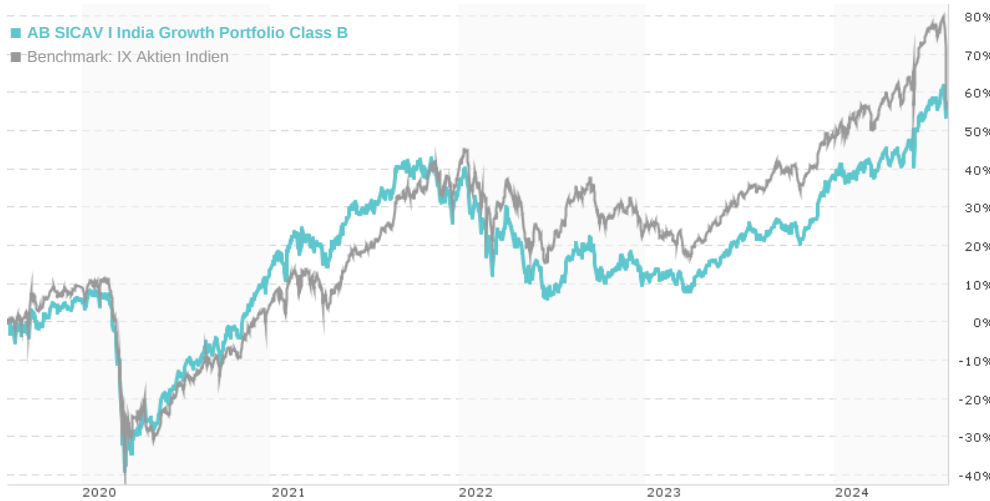

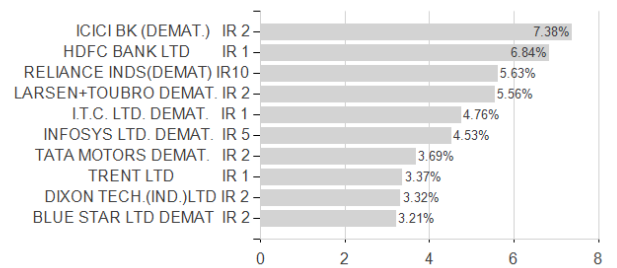
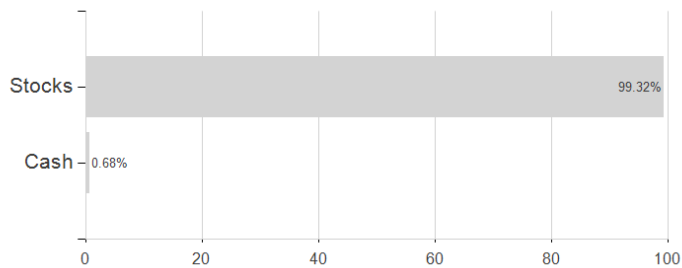
Investment goal
