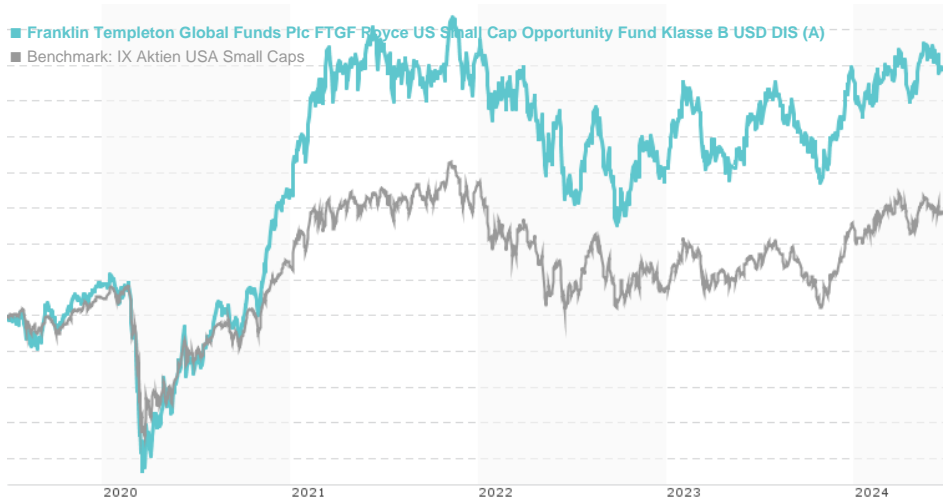

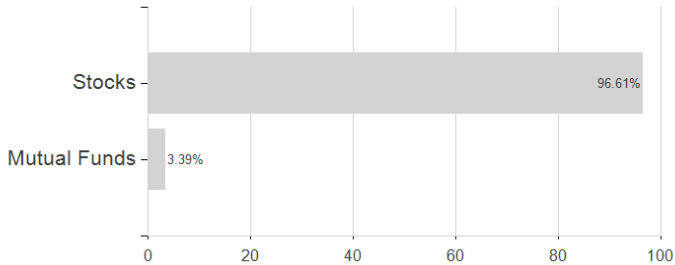

Investment goal

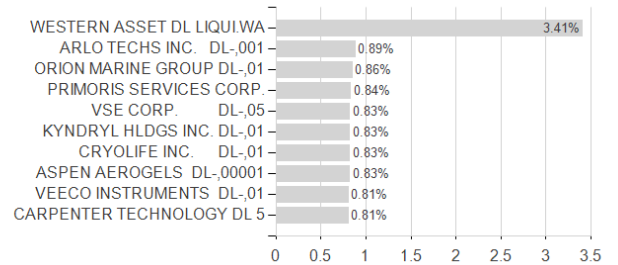

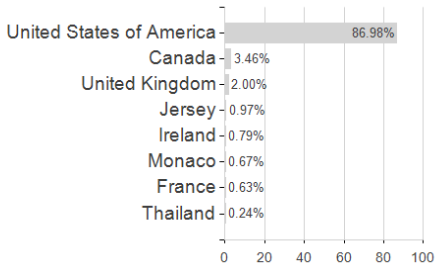

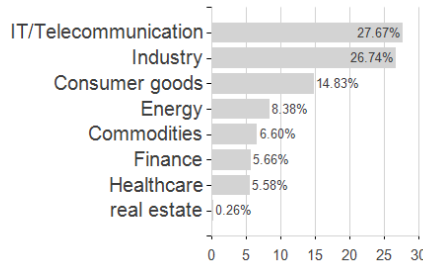
