Investment strategy

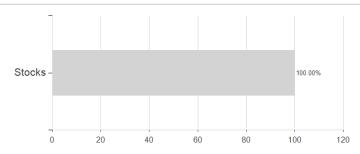

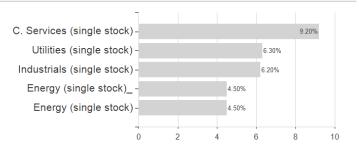
