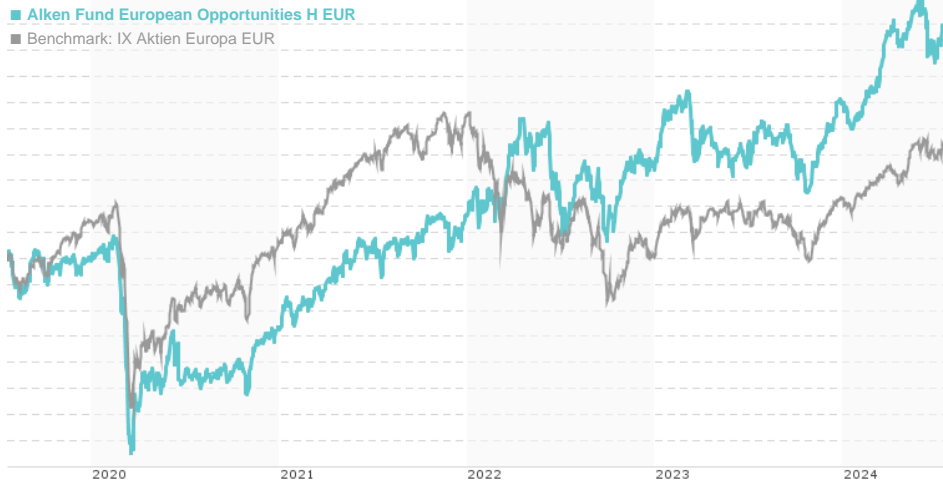

**Investment strategy**

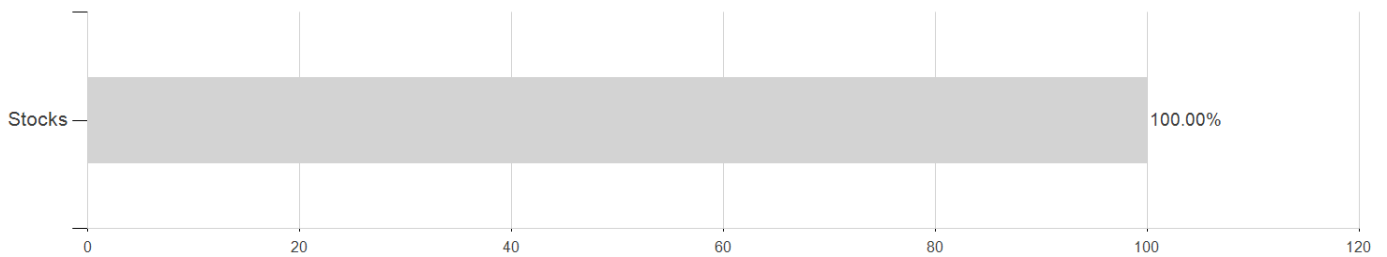

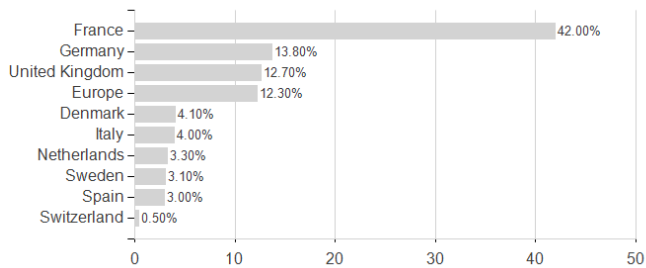
