Investment strategy

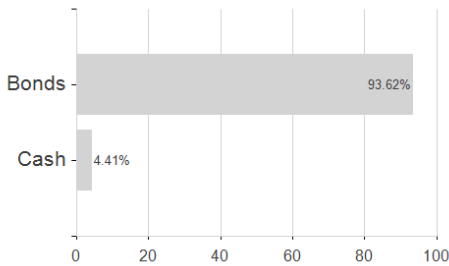

Investment goal

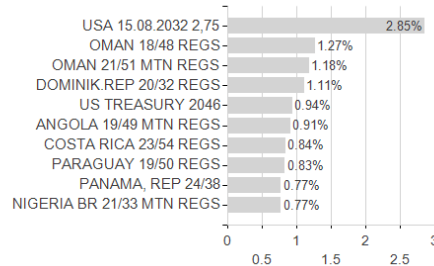
The fund's objective is total return, measured in U.S. dollars.

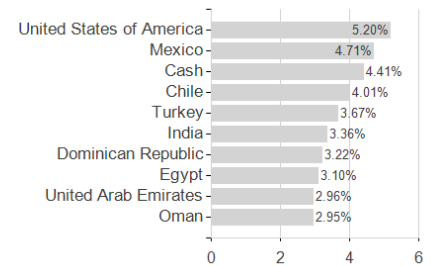

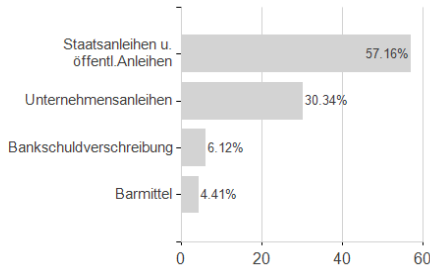

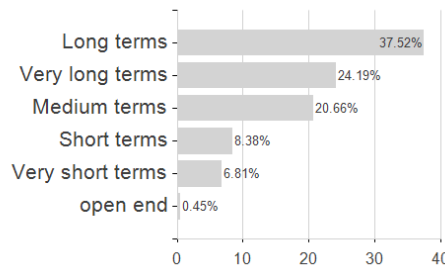
