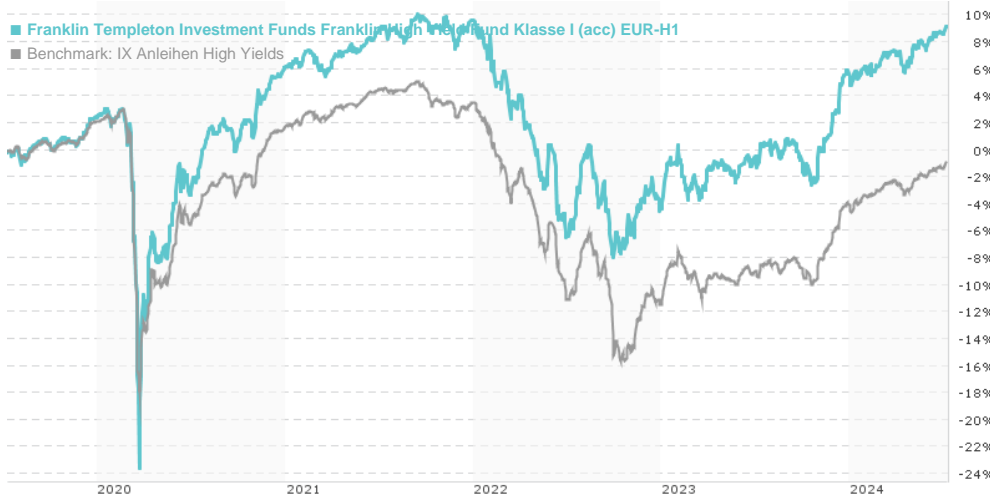

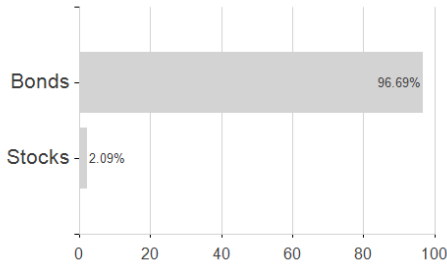

**Investment goal**

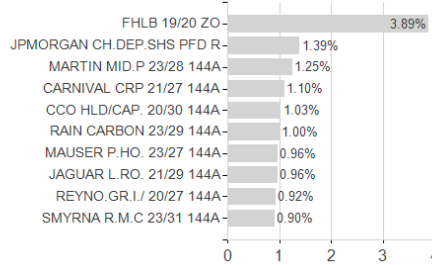

**Assessment Structure**

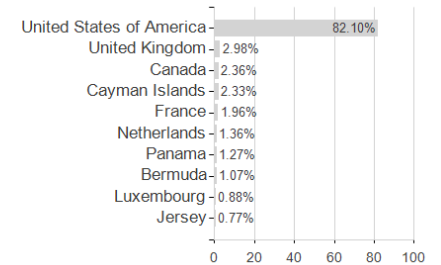

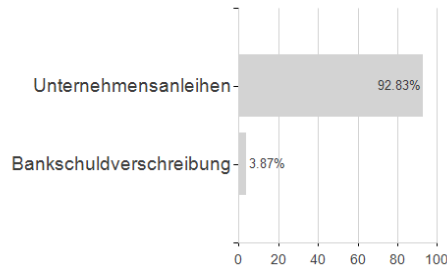

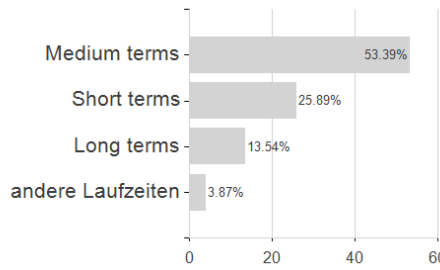
