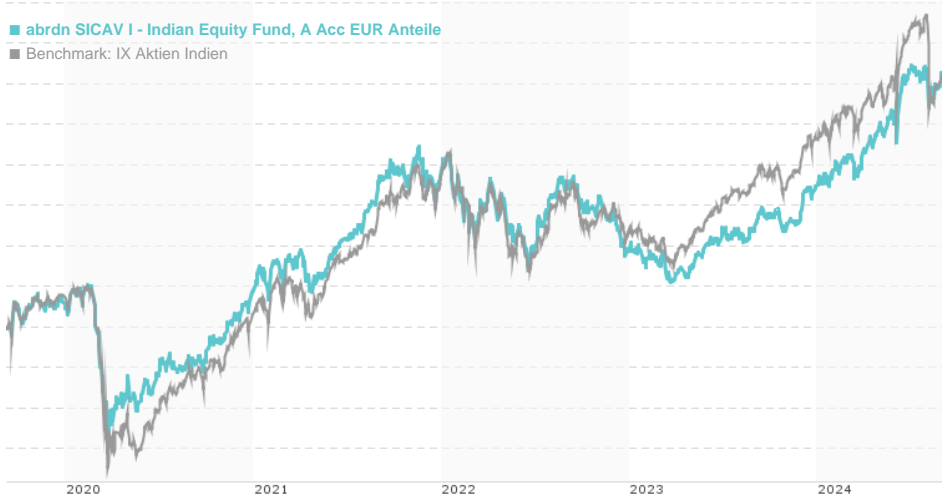

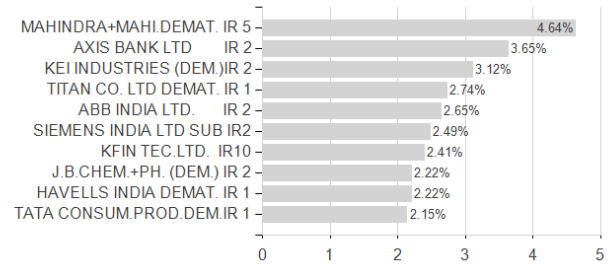
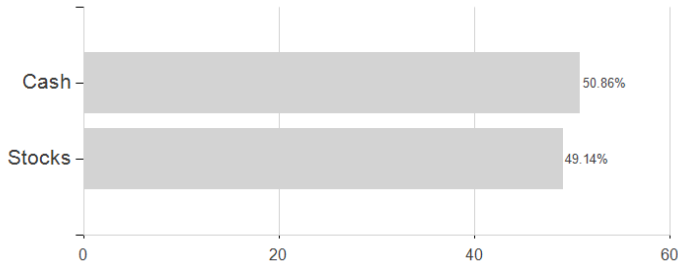
Investment goal
