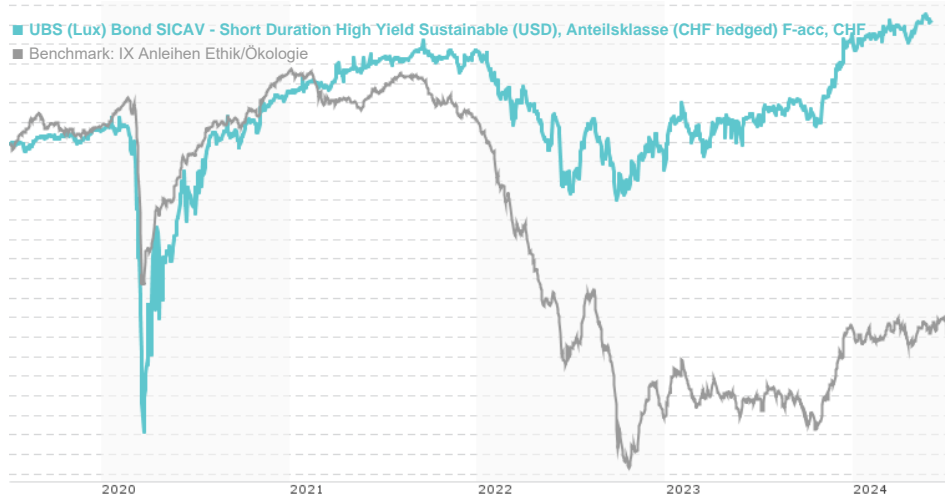

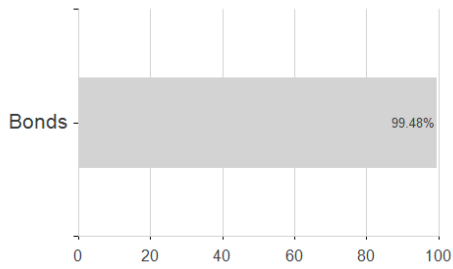

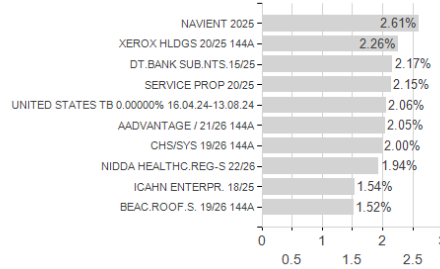

**Assessment Structure**

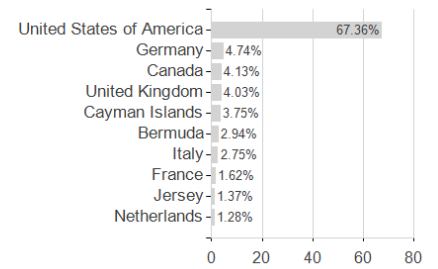

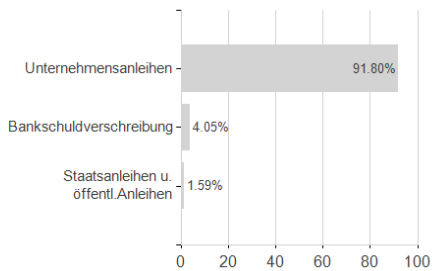

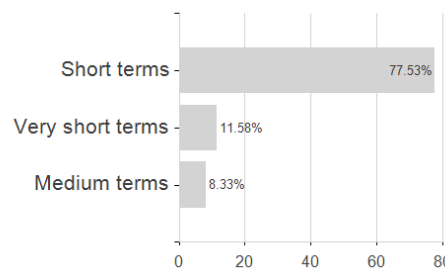
