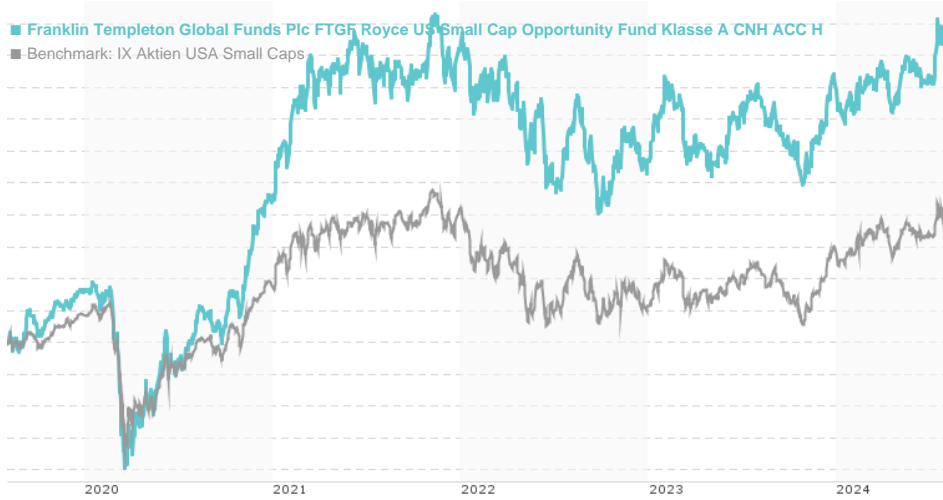

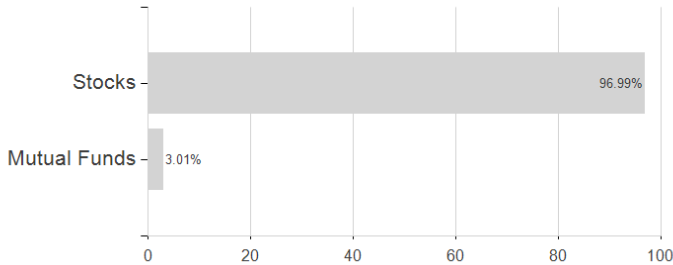

**Investment goal**

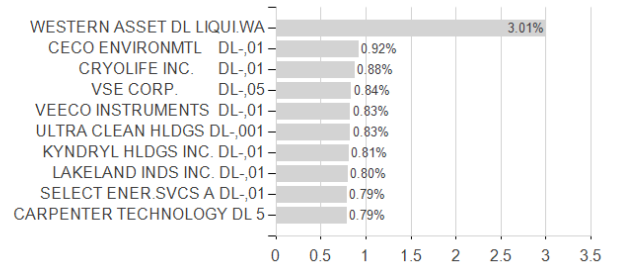

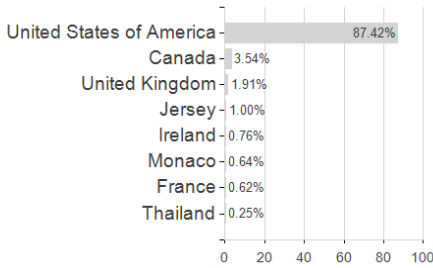

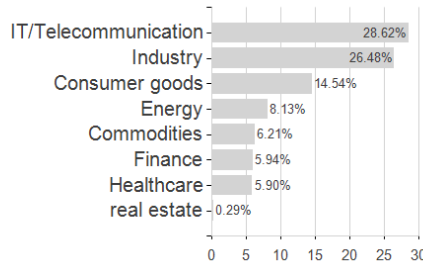
