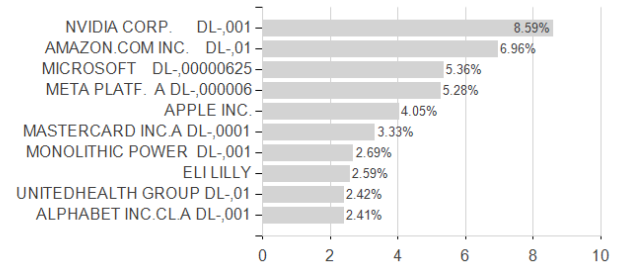
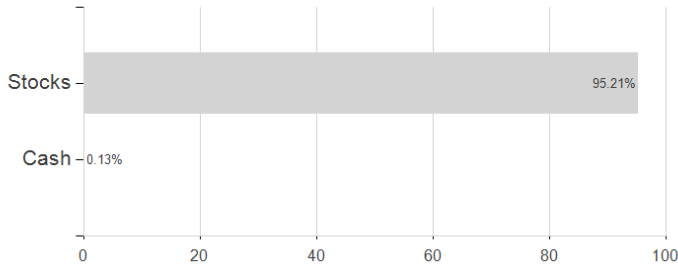
**Investment goal**
