Investment strategy

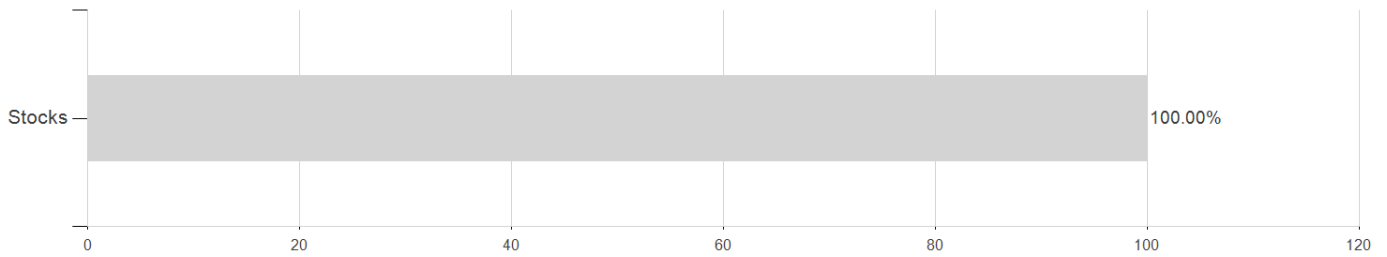

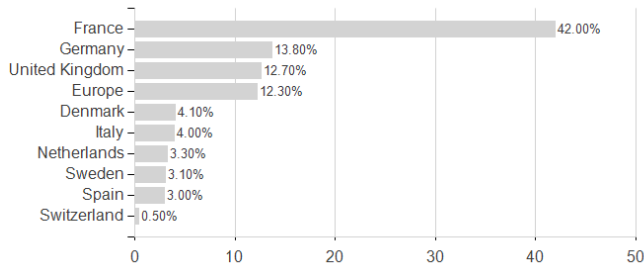
