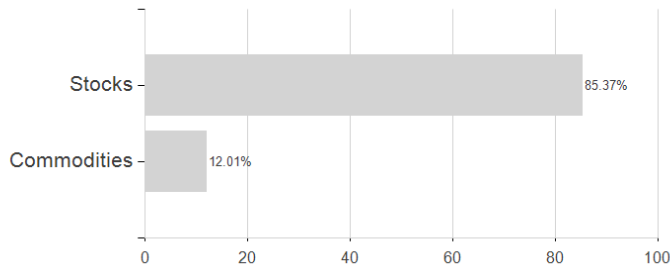

Investment goal

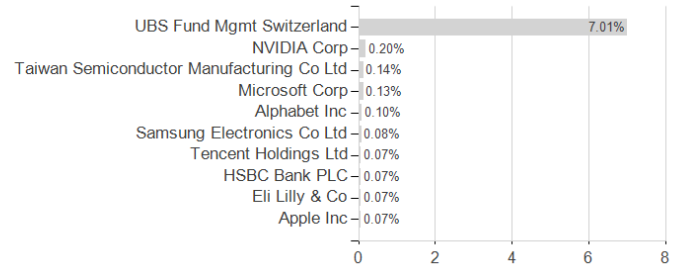

Assessment Structure

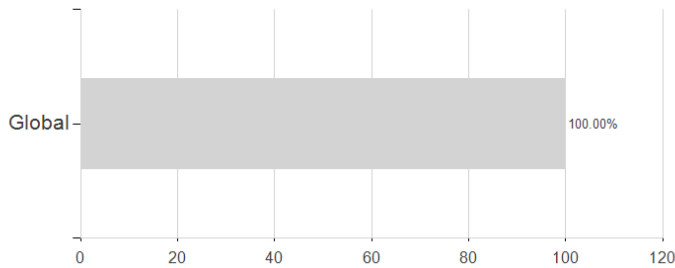
