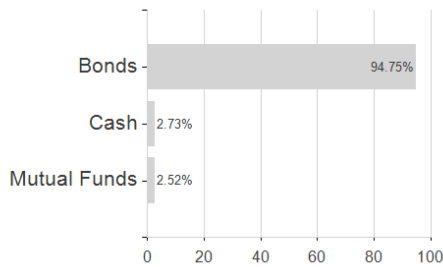

**Investment goal**

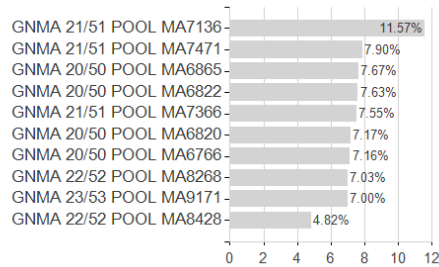

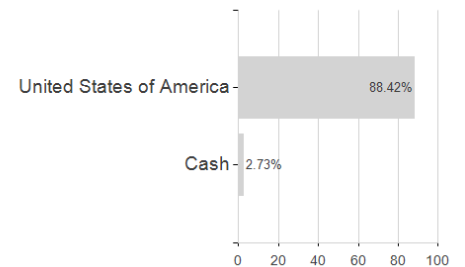
