Investment strategy

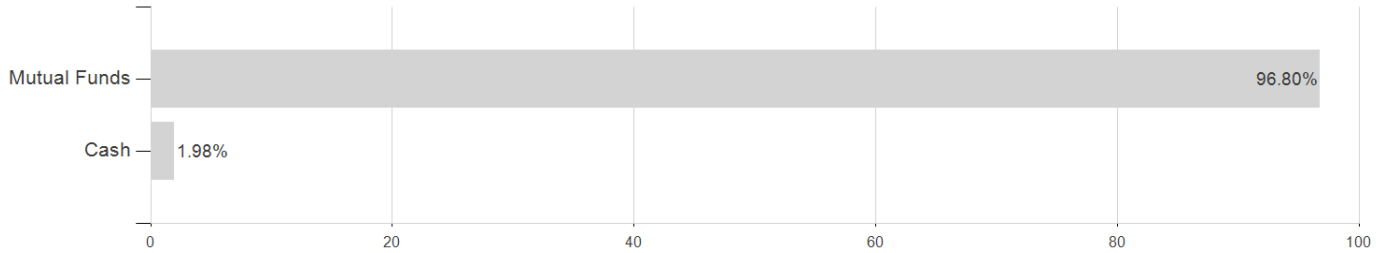

Investment goal

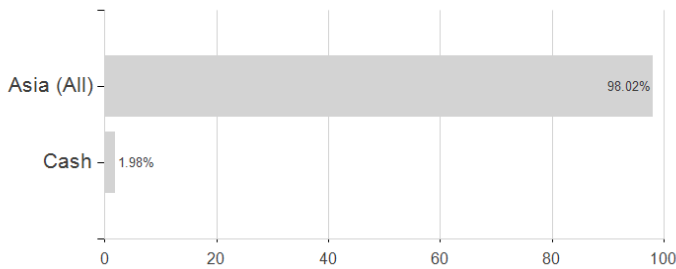
