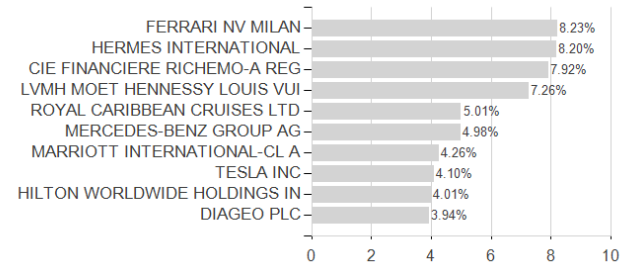
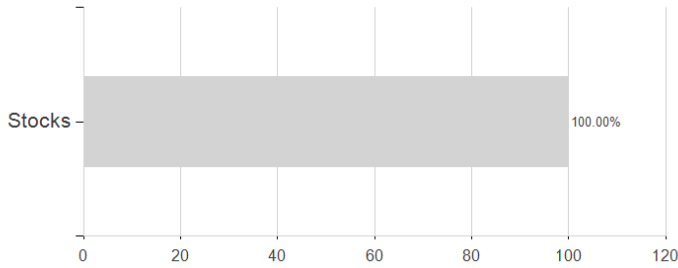
Investment goal
