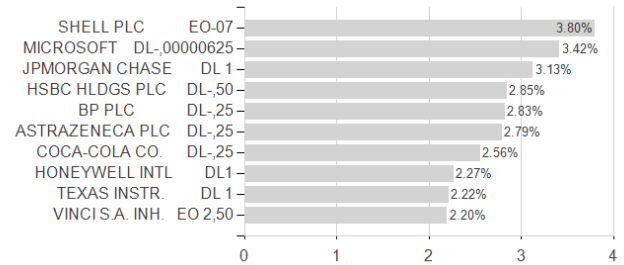
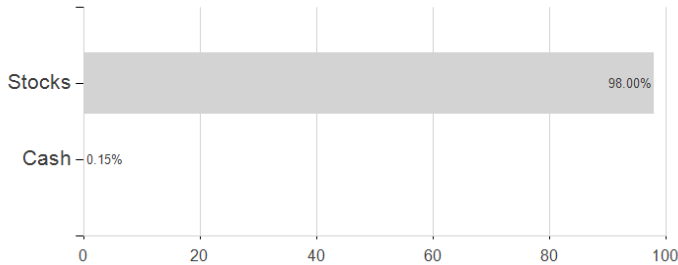
Investment goal
