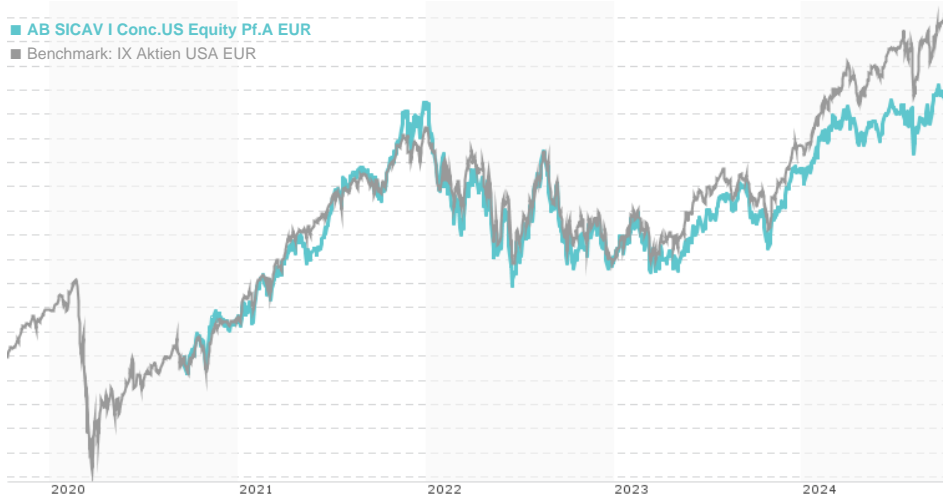

Investment strategy

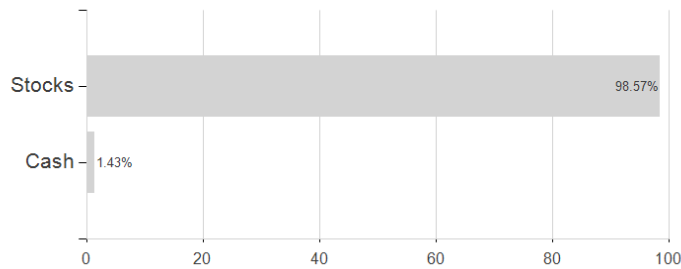

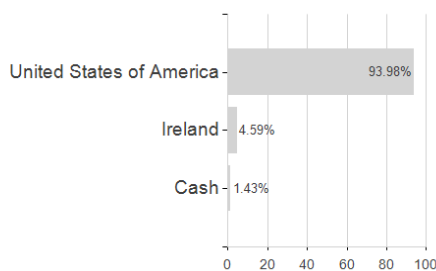
