**Investment strategy**

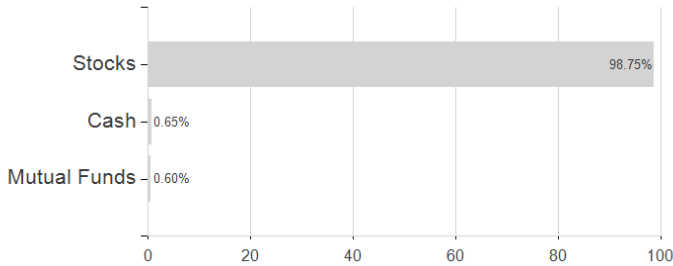

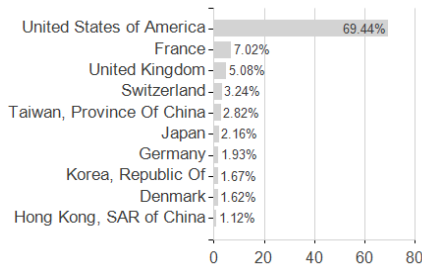
