Investment strategy

Sub-Fund assets are invested in accordance with E/S characteristics. Min. 70% of Sub-Fund assets are invested in Equities and/or government bonds as described in the investment objective. Min. 30% of Sub-Fund assets are invested in government bonds of the Eurozone bond markets. Min. 30% of Sub-Fund assets are invested in Equities and/or bonds other than described in the investment objective. Max. 30% of Sub-Fund assets may be invested in REITs. Max. 20% of Sub-Fund assets may be invested in ABS and/or MBS. Max. 10% of Sub-Fund assets may be invested in Emerging Markets. Sub- Fund assets may not be invested in High-Yield bonds. Max. 70% Sub-Fund assets may be invested in Money Market Instruments and/or (up to 10% of Sub-Fund assets) in money market funds and/or may be held directly in time deposits and/or (up to 20% of Sub-Fund assets) in deposits at sight on a temporary basis for liquidity management and/or defensive purposes. Sub-Fund classifies as "mixed-fund" according to German Investment Tax Act (GITA).

Long-term capital growth by investing in the Eurozone Equity Markets and in the Eurozone government Bond Markets in accordance with E/S characteristics.

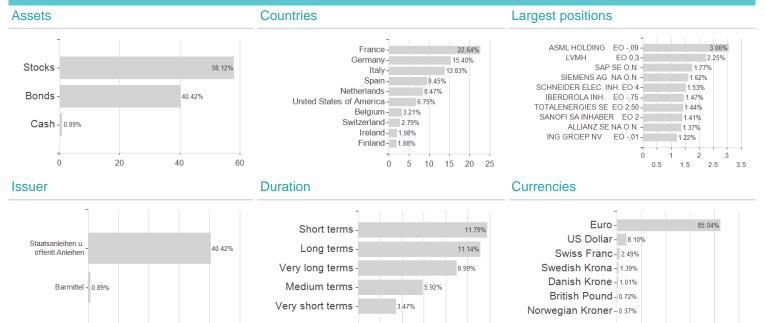
