Investment strategy

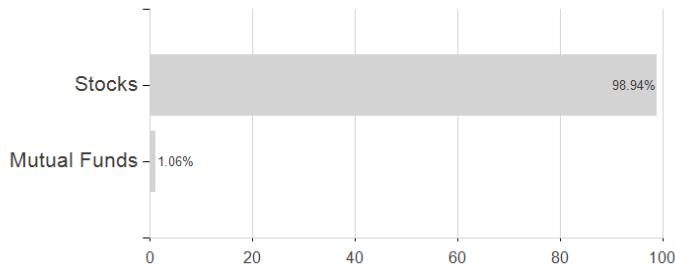

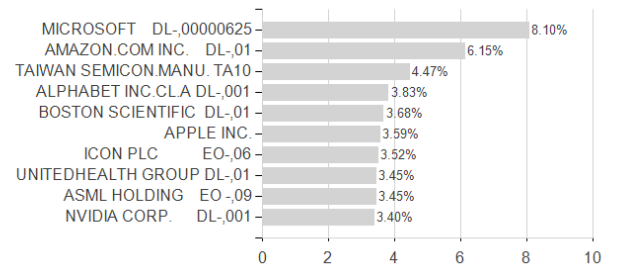

Assessment Structure

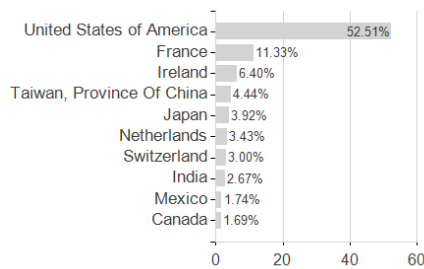

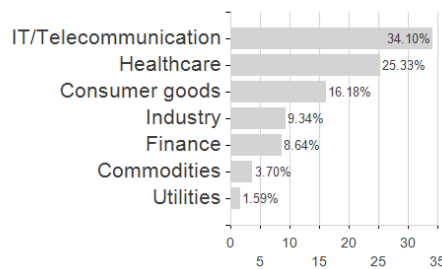
