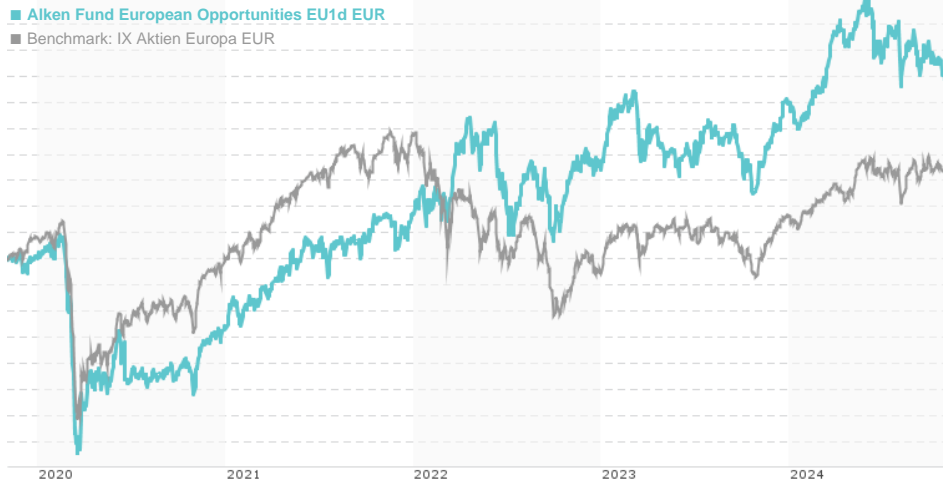

Investment strategy

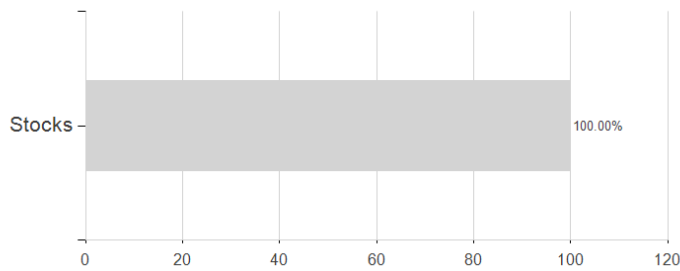

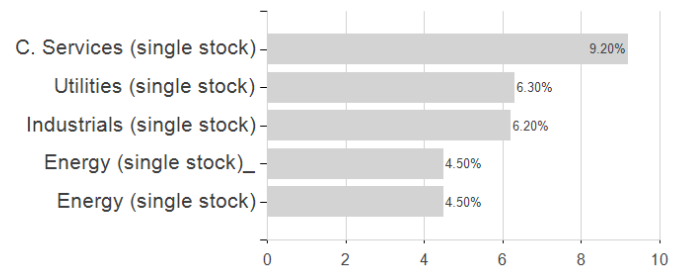

Assessment Structure

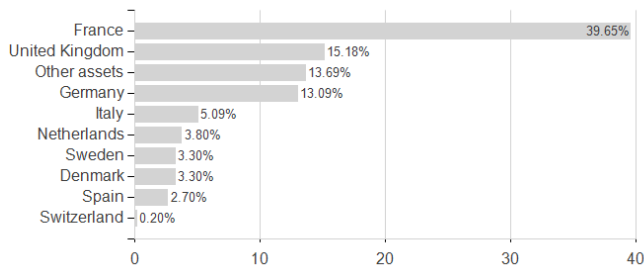
