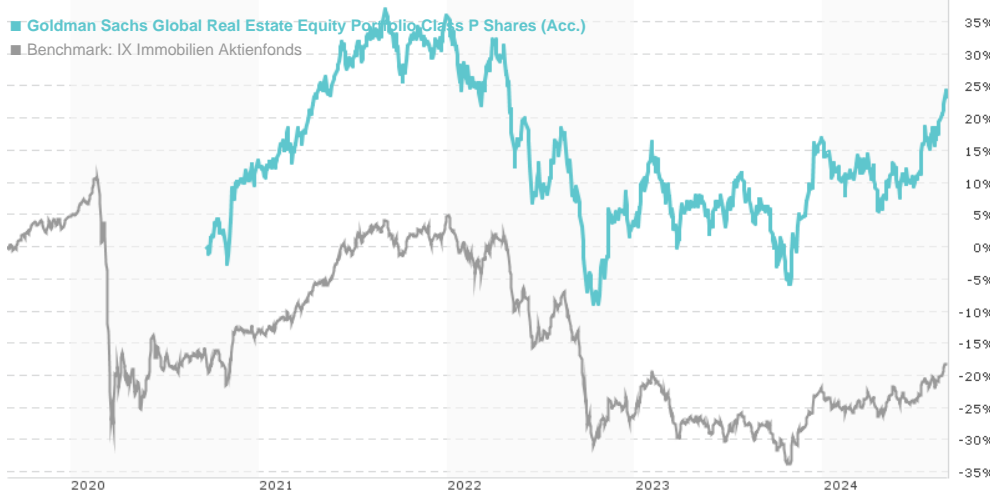

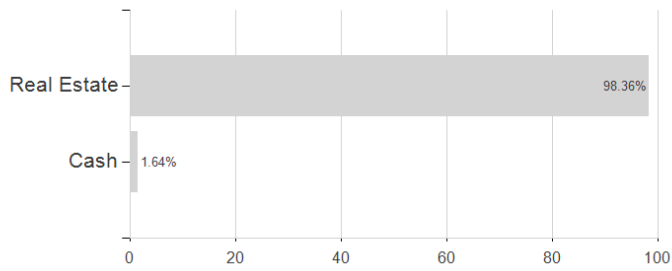

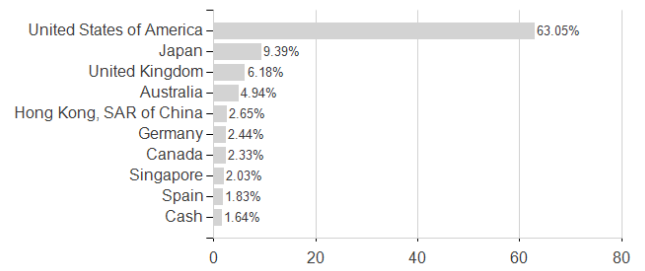

Assessment Structure

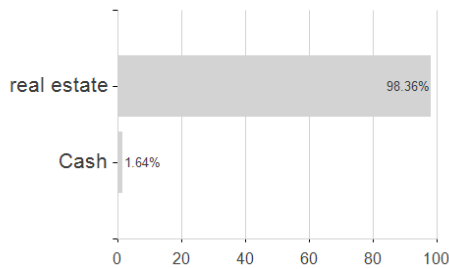

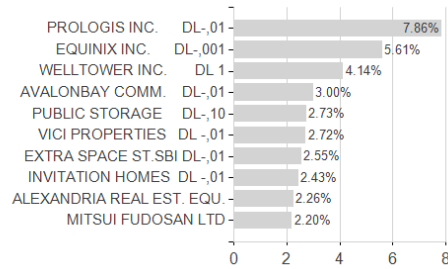
