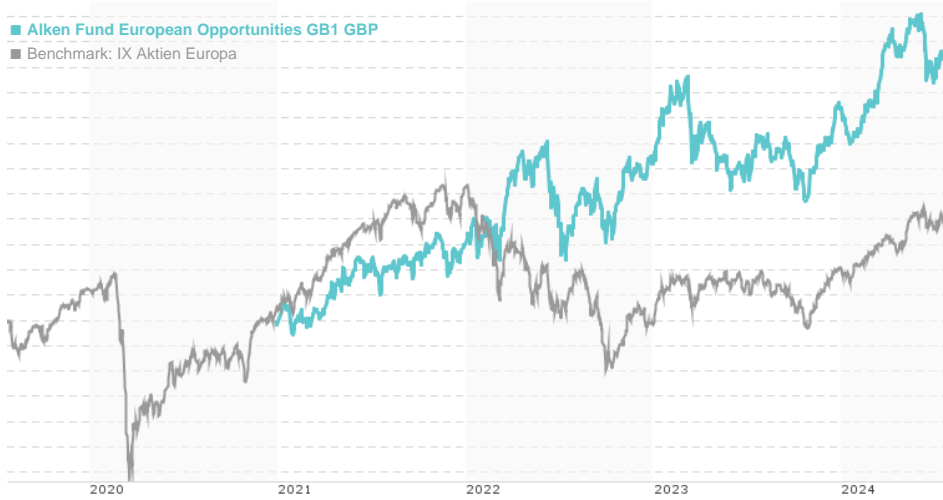

Investment strategy

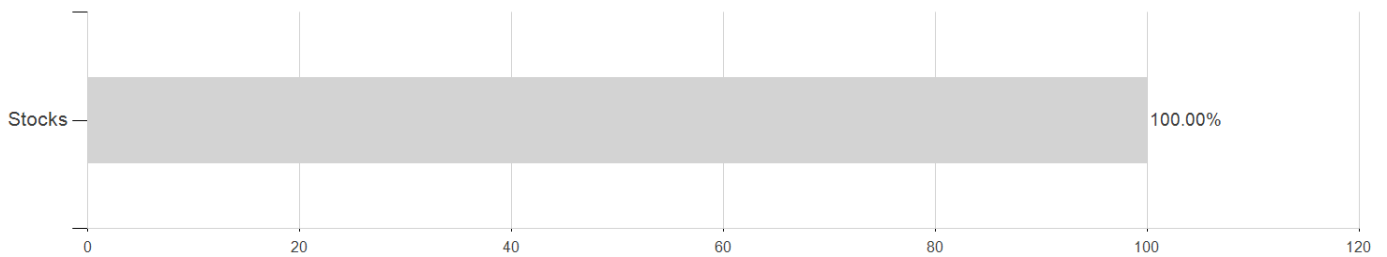

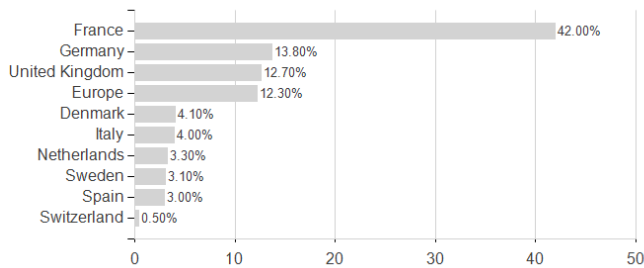
