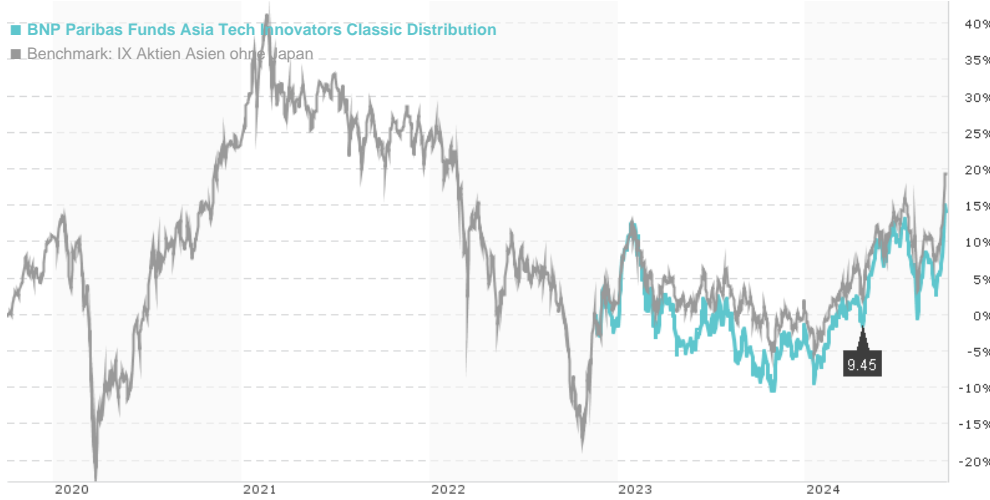

Investment strategy

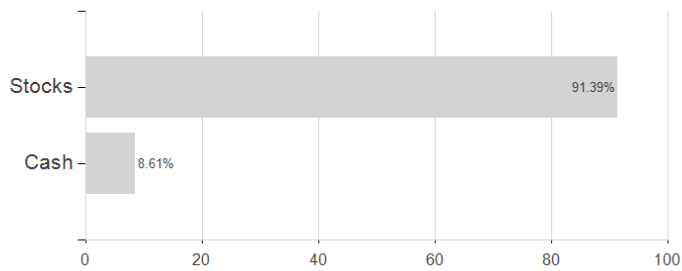
It may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license granted by the Chinese authorities. Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

Investment goal

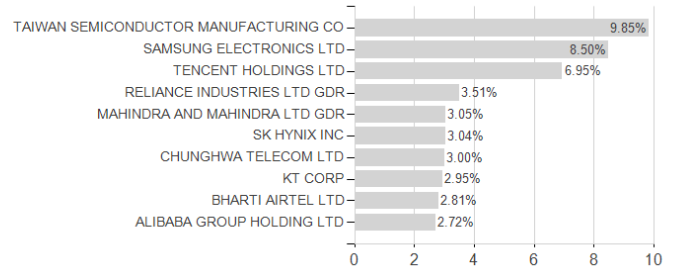

Assessment Structure

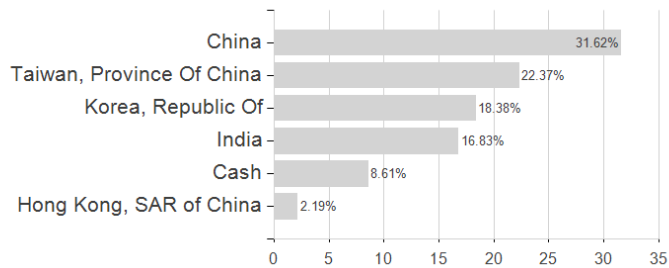
