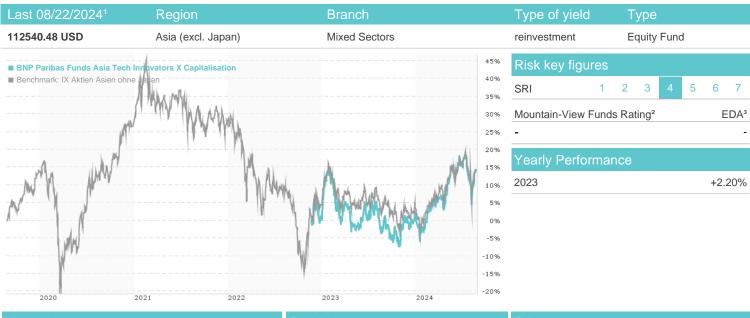

### Investment strategy

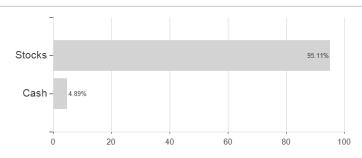

#### Investment goal

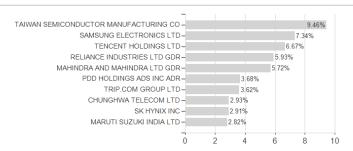
