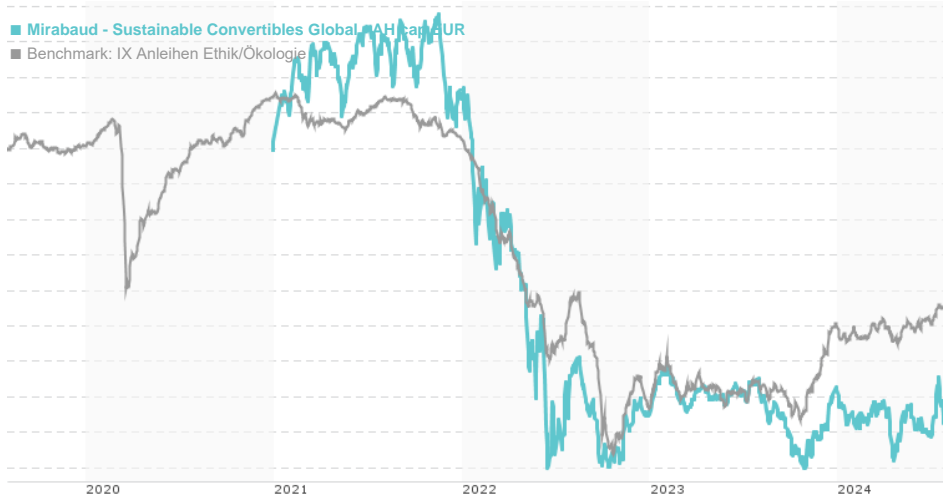

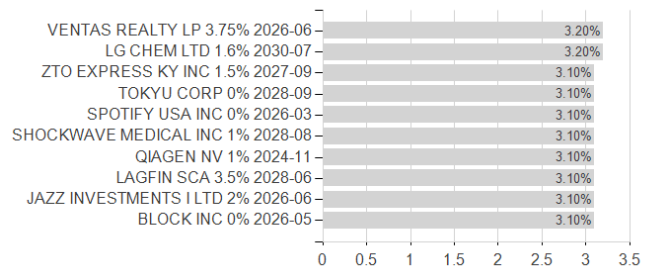
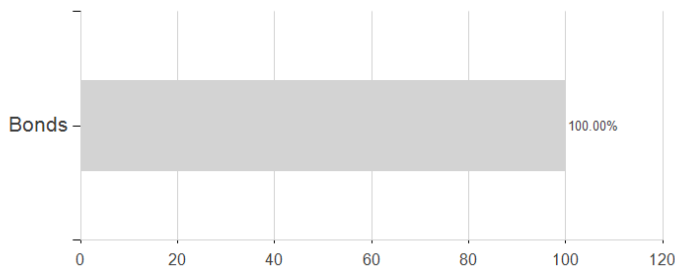
Investment goal
