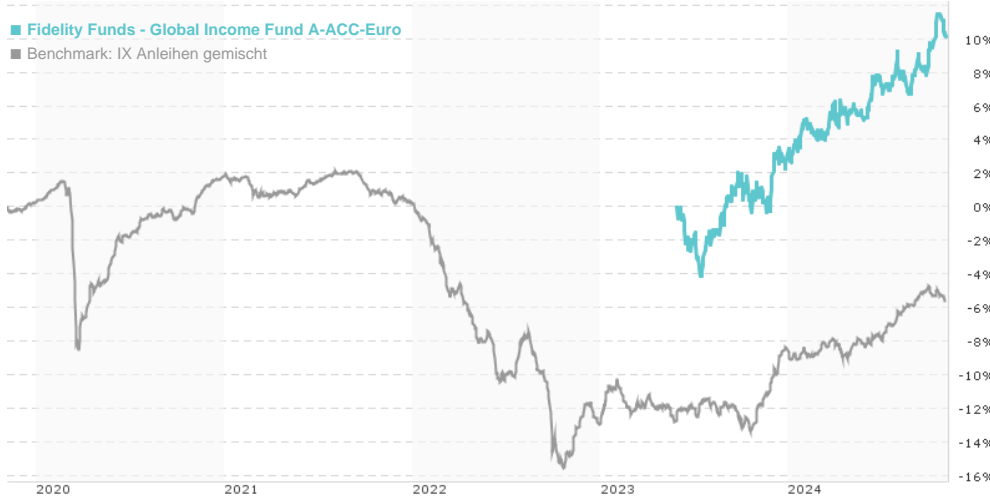

Investment strategy

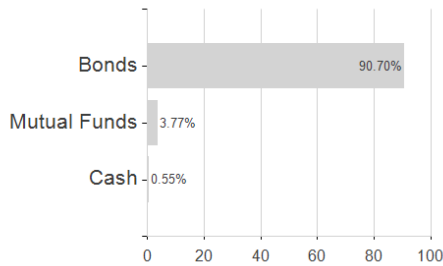

Investment goal

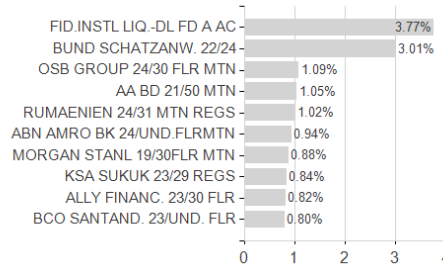
The fund aims to achieve capital growth over time and provide a high level of income.

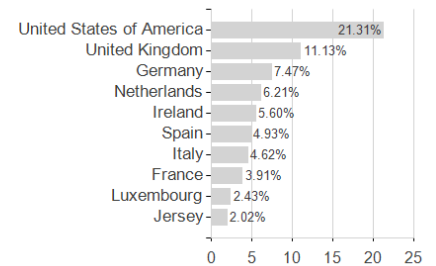

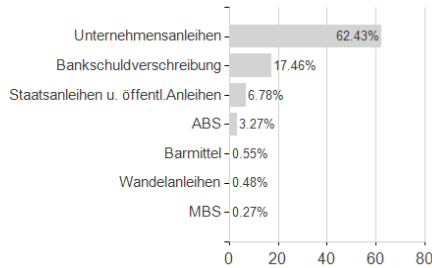

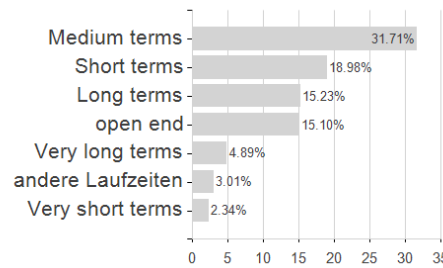
