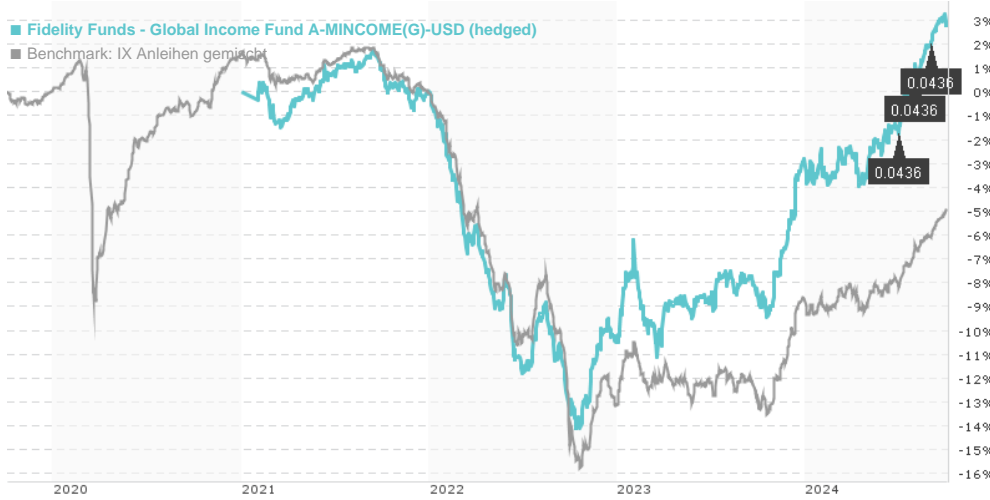

**Investment strategy**

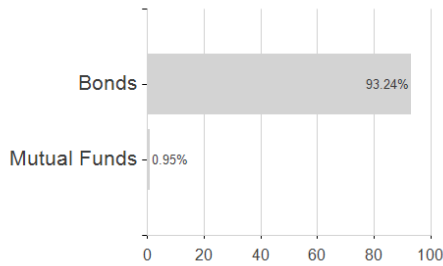

**Investment goal**

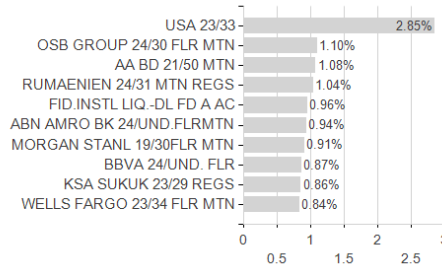
The fund aims to achieve capital growth over time and provide a high level of income.

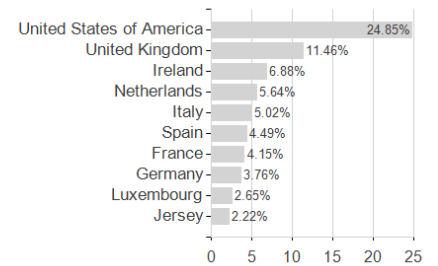

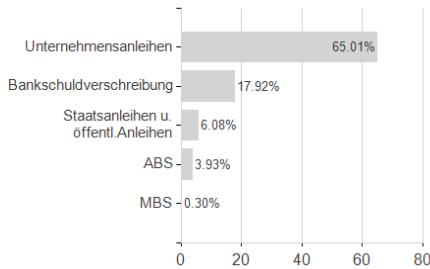

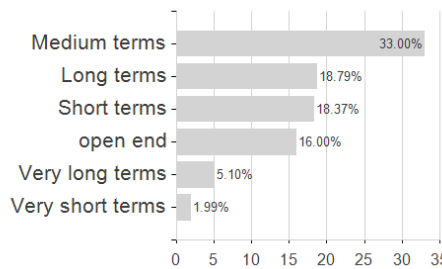
