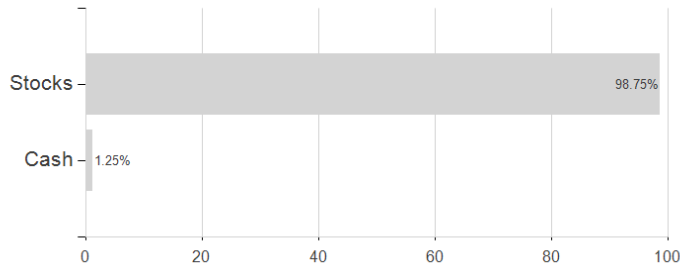

**Investment goal**

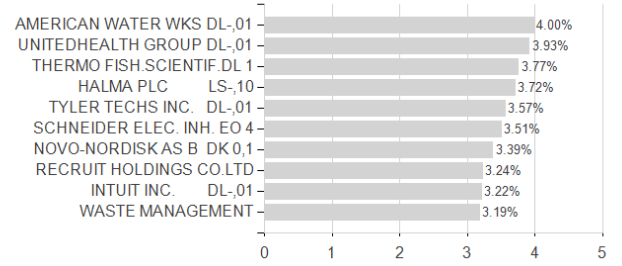

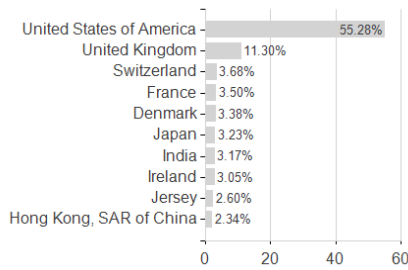

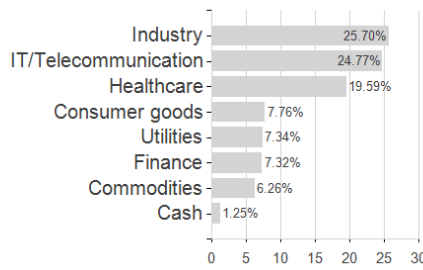
