**Investment strategy**

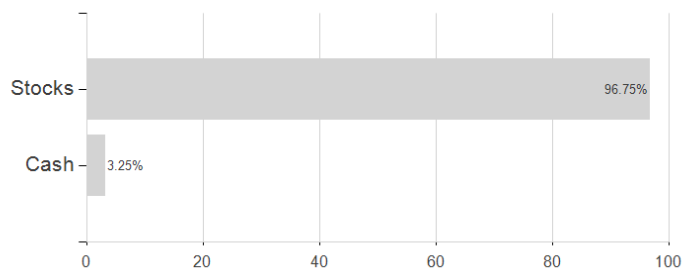

**Investment goal**

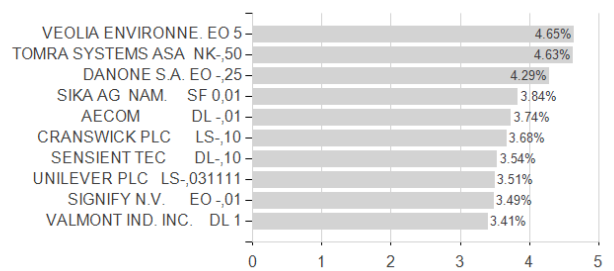

**Assessment Structure**

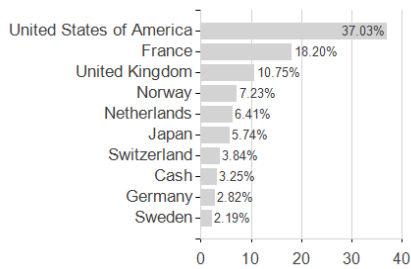

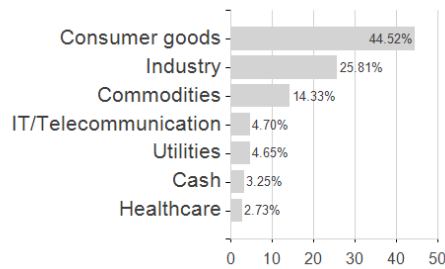
