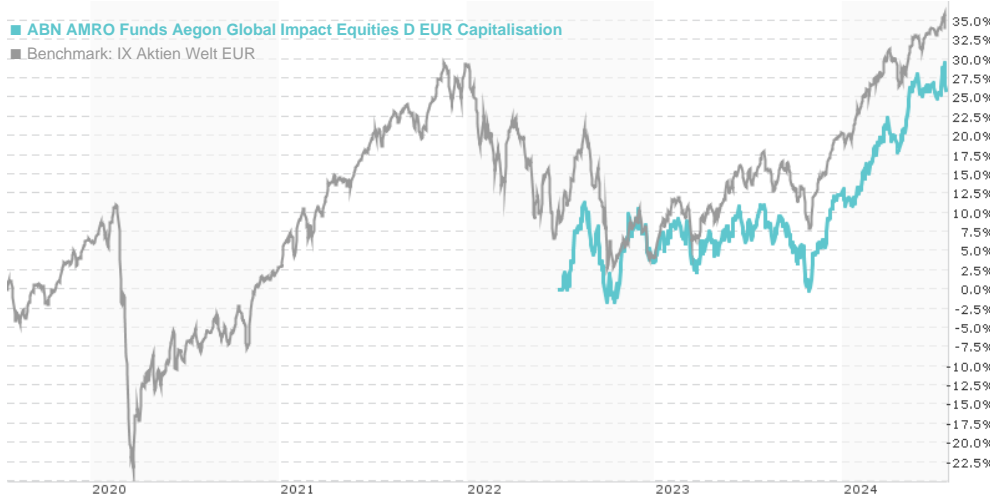

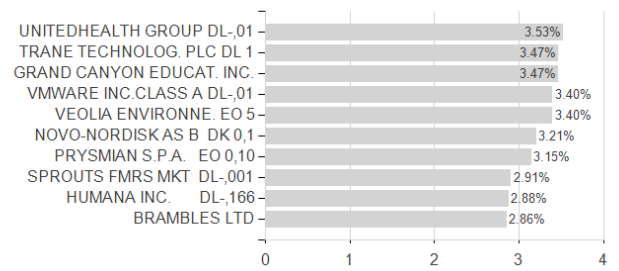
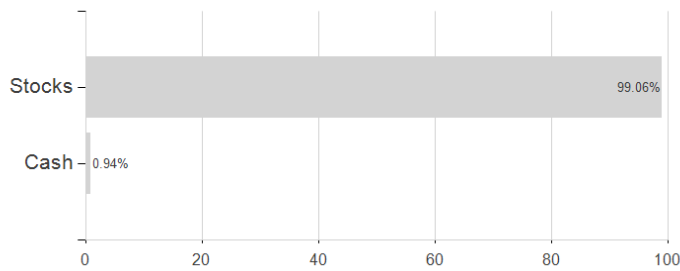
Investment goal
