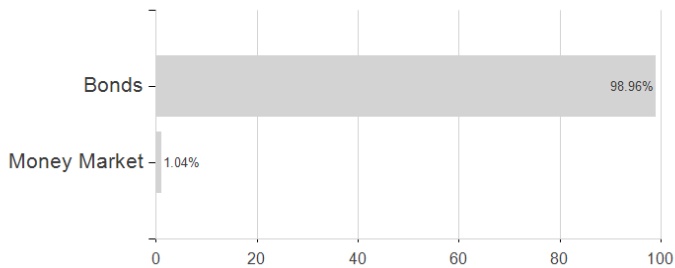

Investment goal

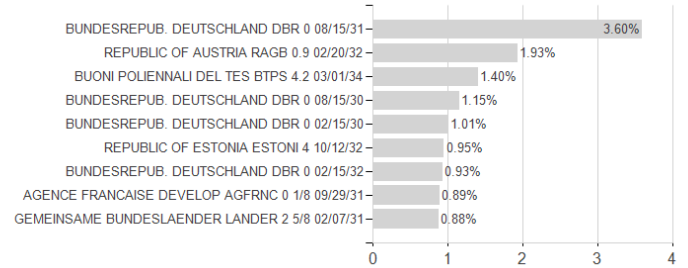

Assessment Structure

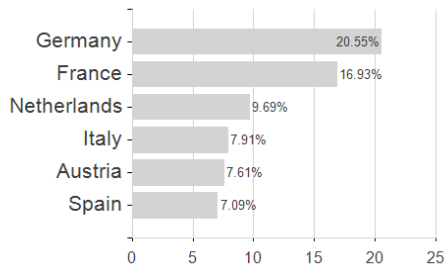

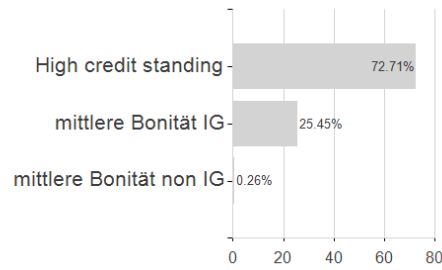
