## What is this product?

#### Type

This is an open-ended investment fund.

#### Term

The Portfolio does not have a specific maturity date. The Board may unilaterally decide to liquidate the Portfolio in accordance with the Fund's prospectus.

#### Investment objective

The Portfolio seeks to increase the value of your investment over time through a combination of capital growth and income (total return).

#### Investment policy

Under normal market conditions, the Portfolio typically invests in equity securities and debt securities of any credit quality of issuers that are organised, or have substantial business activities, in the US. These issuers may be of any market capitalisation and industry.

The Portfolio may also seek exposure to other asset classes such as commodities, real estate, currencies, interest rates, and call and put options, as well as to eligible indices. The Portfolio is not limited in its exposure to equities, debt securities or currencies. The Portfolio expects to invest through other UCITS and ETFs to gain exposure to certain asset classes permitted by this investment policy.

The Portfolio may invest in or be exposed up to (i) 40% in debt securities rated below Investment Grade, (ii) 20% in structured products such as asset-backed and mortgage-backed securities, and (iii) 20% in contingent convertible bonds (CoCos).

The Portfolio may be exposed to any currency.

The Portfolio is not subject to the 10% limits for investments in UCITS and other UCIs (including eligible ETFs).

The Portfolio uses derivatives to a significant extent for hedging (reducing risks), efficient portfolio management and other investment purposes (including to gain additional exposure).

#### Terms to understand

**Asset-backed securities:** Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

**Below Investment Grade Securities:** Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

**Contingent convertible bonds ("CoCos"):** CoCos are a type of contingent security issued by global financial institutions. CoCos are usually subordinated and convert to the issuer's equity and/or have a write-down following the occurrence of a pre-determined event.

**Debt securities:** Securities that represent the obligation to pay a debt, with interest.

**Derivatives:** Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

**Equities:** Securities that represent an ownership stake in a company.

**ETFs:** An exchange traded fund that qualifies as UCITS or eligible UCI within the meaning of Article 41(1)(e) of the law of 17 December 2010 on undertakings for collective investment, as amended.

Investment Grade Securities: Debt securities rated at or above BBB-/Baa3.

**Mortgage-backed securities:** Debt securities representing an interest in a pool of mortgages.

**UCITS:** An undertaking for collective investment in transferable securities that comply with the law of 17 December 2010 on undertakings for collective investment, as amended.

#### Responsible investing

The Portfolio is classified as Article 8 under Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (SFDR). ## Benchmark

The Portfolio is actively managed and its investments are not made in any reference to any benchmark.

## Intended retail investor

The Portfolio is intended for investors with a basic knowledge and limited/no experience of investing in funds. This Portfolio is intended for investors seeking to increase the value of their investment over the recommended holding period and understand the risk of losing some or all the capital invested.

#### Portfolio currency

The reference currency of the Portfolio is USD.

## Share class currency

The reference currency of the share class is EUR.

## Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Portfolio are reinvested.

#### Redemption

# What are the risks and what could I get in return?

The risk indicator assumes you keep your investment in the Portfolio for 5 years.

This is the recommended holding period for this Portfolio.

You may not be able to sell your shares easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this Portfolio compared to other investment funds. It shows how likely it is that the Portfolio will lose money because of movements in the markets.

The Portfolio is classified as 4 out of 7, which is a medium risk class.

Risks materially relevant to the Portfolio but not adequately captured by the SRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

**Allocation risk:** The Portfolio's allocation to various asset classes may change over time and this could impact the performance of the Portfolio positively or negatively.

**Counterparty risk:** If an entity with which the Portfolio does business becomes insolvent, payments owed to the Portfolio could be delayed, reduced and/or eliminated.

**Currency risk:** In the event of a share class denominated in a different currency than the investor's local currency, the return of the investor will be impacted by the exchange rate between the share class currency and the investor's local currency.

**Liquidity risk:** Certain securities could become hard to buy or to sell at a desired time or price.

## Performance Scenarios

What you will get from this share class depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the share class over the last 10 years. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. For any periods before the share class activation/reactivation, 45% S&P 500 TR Index, 45% Bloomberg US Corporate High Yield Index, 10% Bloomberg US Treasuries Index and a similar share class proxy (if applicable) was used to replicate expected returns.

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest EUR 10,000.

Unfavourable scenario: This type of scenario occurred for an investment in the benchmark between December 2021 and December 2023.

Moderate scenario: This type of scenario occurred for an investment in the benchmark between March 2018 and March 2023.

Favourable scenario: This type of scenario occurred for an investment in the benchmark between April 2014 and April 2019.

# What happens if AllianceBernstein (Luxembourg) S.à r.l. is unable to pay out?

The Fund's assets are held with a separate company, the depositary, so the Fund's ability to pay out would not be affected by the insolvency of AllianceBernstein (Luxembourg) S.à r.l.

However, in the event of the depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation scheme in place which may offset, all or part, of this loss.

## What are the costs?

Costs over time: The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold your investment in the Portfolio. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the share class performs at the greater of 0 % or as shown in the moderate scenario;
- EUR 10,000 is invested.
