## OBJECTIVES AND INVESTMENT POLICY

### Investment objective

The Fund seeks to increase the value of your investment over time through total return, using a combination of income and capital growth.

### Investment policy

Under normal market conditions, the Fund typically invests at least 80% of its assets in debt securities of issuers that the Investment Manager believes are positively aligned with sustainable investment themes as well as at least 70% in debt securities of corporate issuers. These issuers may be from anywhere in the world, including emerging market countries.

The Fund may invest in, or be exposed up to (i) 20% in below Investment Grade debt securities and (ii) 20% in structured products such as asset-backed and mortgage-back securities. The Fund does not invest in debt securities rated Caa1/CCC+/CCC or below.

The Investment Manager invests in securities that it believes are positively exposed to environmentally- or socially-oriented sustainable investment themes derived from the UN Sustainable Development Goals (UNSDGs).

The Investment Manager emphasizes positive selection criteria, in particular by analyzing the exposure to environmental, social and governance (ESG) factors of each security or issuer, over broad-based negative screens in assessing an issuer's exposure to such ESG factors.

The Fund's exposure to ESG bond structures is at least 20%.

The Fund's exposure to EUR is at least 95%.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes.

### Responsible Investing

The Fund is classified as Article 9 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

### Benchmark

Bloomberg Global Aggregate Corporate Index (EUR hedged) used for performance comparison.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark. Please see the Fund's prospectus for more information.

### Hedged share class

This share class seeks to reduce the effect of exchange rate fluctuations between the Fund's base currency and the currency of the share class.

### Fund currency

The reference currency of the Fund is EUR.

### Share class currency

The reference currency of the share class is GBP.

### Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

### Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

### Terms to understand

**Asset-backed securities:** Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

**Below Investment Grade Securities:** Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

**Debt securities:** Securities that represent the obligation to pay a debt, with interest.

**Derivatives:** Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

**Duration:** A measure of how much the price of a fixed-income asset will fluctuate as a result of changes in the interest rate environment. Securities with a higher duration are typically more sensitive and can have greater price fluctuations in case of changes in the interest rates.

**Emerging market countries:** Nations whose economies and securities markets are less established.

**ESG bond structures:** Debt issued by both corporate and sovereign issuers that is designed to encourage sustainability.

**Investment Grade Securities:** Debt securities rated at or above BBB-/Baa3.

**Mortgage-related securities:** Debt securities representing an interest in a pool of mortgages.

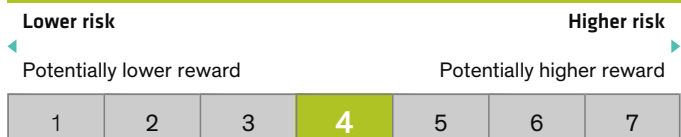
**Other investment purposes:** In line with the Fund's investment objective and policy, means to gain exposure and/or to manage duration.

**SFDR:** Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector.

**Sustainable investment themes:** Those investment themes that are derived from the UNSDGs such as Health, Climate, and Empowerment. Sustainable investment themes may change over time.

**UN Sustainable Development Goals ("UNSDGs"):** A set of 17 goals that represent the United Nations' aspirational view of how the world could look like by 2030. The 17 goals address economic prosperity, environmental sustainability and social inclusion.

## RISK AND REWARD PROFILE



### What does this risk indicator mean?

This synthetic risk and reward indicator (SRRRI) scale rating indicates how the Fund may perform and the risk of losing some or all of your capital. Generally the potential for higher gains also means a larger risk of losses. The lowest category does not mean a risk free investment.

The Fund is not guaranteed in capital. The Fund is invested in debt securities that are subject to variations up or down and that can generate gains or losses.

### Risks materially relevant to the Fund but not adequately captured by the SRRRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

**Counterparty risk:** If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

**Liquidity risk:** Certain securities could become hard to buy or to sell at a desired time or price.

## CHARGES

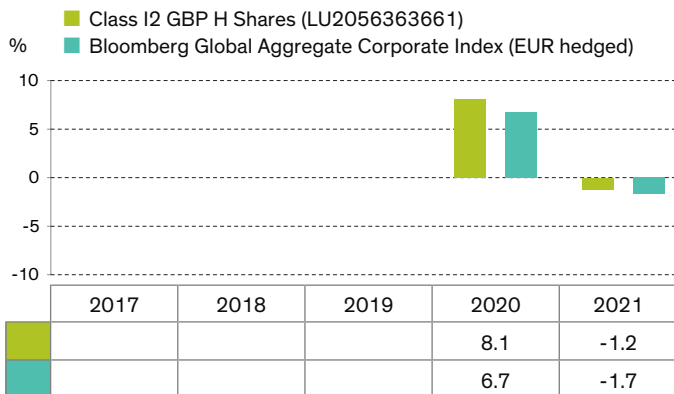
The entry and exit charges shown are maximum figures. In some cases, you might pay less – you can find this out from your financial advisor.
