What is this product?

abrdn-CCBI Belt & Road Bond Fund (the "Fund") is a US Dollar denominated sub-fund of a SICAV (société d'investissement à capital variable), abrdn SICAV I, incorporated in Luxembourg.

abrdn SICAVI (the "Company") has no maturity date. The Fund and the Company may not be unilaterally terminated by abrdn Investments Luxembourg S.A.

Objective

The Fund aims to achieve a combination of income and growth by investing in bonds (which are like loans that can pay a fixed or variable interest rate) issued by companies, governments or other bodies, which in the view of the Investment Manager, could directly or indirectly benefit from the Belt

The Belt and Road Initiative is a systematic initiative and global development strategy launched by the Chinese government in 2013 to promote the land and sea connectivity along Ásia, Europe, Middle-East, and Africa and their adjacent seas (i.e. the Belt and Road Region) to establish and strengthen economic partnerships and cooperation along these regions.

Portfolio Securities

- The Fund invests at least two-thirds of its assets in bonds issued by government or government-related bodies and/or corporations which, in the view of the Investment Manager, could directly or indirectly benefit from the Belt and Road Initiative.
- The bonds will be of any maturity or credit quality. The Fund may invest up to 100% in Sub -Investment Grade bonds.
- The Fund will invest at least 80% of its assets in bonds denominated in US Dollars. Bonds denominated in other currencies will typically be hedged back to US Dollars.

Management Process

- The Fund is actively managed and does not use a benchmark for portfolio construction, risk management or performance assessment purposes.
- The Investment Manager will aim to diversify country exposure but may at times hold a significant proportion in bonds issued by the Chinese government, government-related bodies or Chinese companies.
- CCB International Asset Management Limited, ("CCBI") has been appointed as investment advisor with respect to the Fund and provides nonbinding investment advice in connection with the Belt and Road Initiative.
- Our investment team will seek to reduce the risk of losses and the expected change (as measured by annual volatility) in the value of the Fund is not ordinarily expected to exceed 10%.
- The Investment Manager will review each investment on its own merits and how it is aligned with and expected to benefit from China's Belt and Road initiative. The Investment Manager will assess how the countries and companies exposed to the Belt and Road Region with their respective economies, resources and businesses will cooperate and mutually complement each other in different areas or sectors.

Derivatives and Techniques

- Derivatives will only be used for hedging or to provide exposures that could be achieved through investment in the assets in which the Fund is primarily invested. Usage of derivatives is monitored to ensure that the Fund is not exposed to excessive or unintended risks.

This fund is subject to Article 6 of the Sustainable Finance Disclosure Regulation ("SFDR").

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus). If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.


Intended Retail Investor

What are the risks and what could I get in return?
