## **OBJECTIVES AND INVESTMENT POLICY**

### **Investment Objective**

The Fund aims to achieve a combination of growth and income by

investing in companies in China. The Fund aims to outperform the MSCI China All Shares Index (USD) benchmark before charges.

#### **Investment Policy** Portfolio Securities

- The Fund invests at least two thirds in equities and equity related securities of companies based, or carrying out much of their business in
- -The Fund may invest up to 100% of its net assets in Mainland China equity and equity-related securities, including through the Shanghai-Hong Kong and Shenzhen-Hong Kong Stock Connect programme or by any other available means, a 30% limit applies to QFI regime.

**Management Process** 

- The Fund is actively managed.
  The benchmark is used as a reference point for portfolio construction and as a basis for setting risk constraints.
  In order to achieve its objective, the Fund will take positions whose
- weightings diverge from the benchmark or invest in securities which are not included in the benchmark. The investments of the Fund may deviate significantly from the components and their weightings in the benchmark.
- Due to the active nature of the management process, the Fund's performance profile may deviate significantly from that of the benchmark over the longer term.

- The Fund may utilise financial derivative instruments for hedging and/ or investment purposes, or to manage foreign exchange risks. The use of derivatives for investment purposes is expected to be very limited, mainly in those cases where there are significant inflows into the Fund so that cash can be invested while the investment in equity and equity related securities is maintained. Investors in the fund may buy and sell shares on any dealing day (as

defined in the Prospectus).

If you invest in income shares, income from investments in the fund will

be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.


