Objectives and investment policy

The objective of Arabesque Q3.17 SICAV - Global ESG Momentum Equity ("Sub-Fund") is long-term capital appreciation through investments into a sustainable Sharia-compliant equity universe (Arabesque Investment Universe). The Arabesque Investment Universe is determined on a guarterly basis.

The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

The Sub-Fund promotes certain environmental and social characteristics within the meaning of article 8 of SFDR but does not have a sustainable investment objective.

The Fund Manager integrates sustainability risks and opportunities into its research, analysis and investment decision-making processes. The Sub-Fund is managed to promote, among other characteristics, a combination of environmental and social characteristics (as provided under article 8 of SFDR), but does not have as its objective sustainable investments.

The Arabesque Investment Universe contains Sharia-compliant equities and equity-related securities (equity securities) from companies worldwide that have passed a systematic selection process. Companies that are in breach of the principles of UN Global Compact (human rights, labour rights, anticorruption, environment) are excluded as well. The Arabesque Investment Universe is furthermore screened by liquidity parameters such as market capitalization, daily turnover and free float.

The Sub-Fund will mainly invest in equities and equity related securities (such as, but not limited to, ordinary shares, certificates, ADR, GDR, notes) issued by companies worldwide that are contained in the Arabesque Investment Universe.

Why is this Sub-Fund in this category?

The investment objective of the Sub-Fund is to generate long-term capital appreciation through investments into a sustainable Sharia-compliant equity universe (Arabesque Investment Universe). Stock selection is determined by a quantitative approach. The Arabesque Investment Universe is determined on a quarterly basis. The Sub-Fund will present a risk/reward profile corresponding to a High risk category on the risk/ reward scale.

Are there any other particular Risks?

Risks that could affect Sub-Fund performance and are not necessarily fully reflected in the risk and reward rating include:

• Liquidity risks: The Sub-Fund may be exposed to less liquid securities.

The net asset value for this Class is calculated on each business day in Luxembourg ("Calculation Day") based on the pricing of the preceding full business day ("Valuation Day"). The cut-off time to submit subscription and/or redemption orders is 2 p.m. Luxembourg time on the full bank business day in Luxembourg preceding the relevant Calculation Day.

Distribution Policy

The income on all classes of the Sub-Fund may be distributed.

Currency

The currency of the Class is USD.

Minimum Investment

The minimum subscription amount is 50'000 USD.


