### What is this product?

Type: The Fund is a mutual investment fund qualifying as an undertaking for collective investment in transferable securities (UCITS) established under Luxembourg law.

Term: This product has no specific maturity date.

Azimut Investments S.A. is entitled to terminate the contract unilaterally.

Azimut Investments S.A. may terminate the contract unilaterally inter alia in case of liquidation or merger of the Sub-fund. Please refer to the prospectus for additional informations on early termination circumstances.

#### **Objectives**

The Sub-fund's investment objective is to achieve medium and long-term capital growth.

The Sub-fund aims to achieve its investment objective by actively managing a diversified portfolio of equities as well as debt securities issued worldwide. Investments in equities are actively managed by balancing the risk contribution among the following investment factor: Momentum (assets with positive risk-adjusted returns over an extended period of time), Carry (assets with higher than average growth potential), Value (assets that are undervalued in relation to their fundamentals), Size (assets with a high market capitalisation), Quality (assets with strong accounting, economic and financial data) and Low Risk (assets with low volatility or beta). Equity exposure is actively managed and depends on the overall volatility of investment factors. The remaining portion of the portfolio is invested in debt securities with an attractive yield to maturity in order to enhance the Sub-fund's return.

The Sub-fund invests at least 20% of its net assets in equity and equity-related securities issued by companies worldwide.

The Sub-fund may also invest up to 50% of its net assets in debt securities and money market instruments issued by governments, supranational institutions or governmental authorities of developed countries and/or companies headquartered in developed countries.

The Sub-fund may also invest up to 40% of its net assets in debt securities rated sub-investment grade.

The Sub-fund uses the main derivative financial instruments for investment purposes and/or for hedging purposes. The Sub-fund aims at maintaining a leverage effect lower than 400%, calculated on the total of all derivative financial instruments' notional amounts.

The Sub-fund is actively managed. The 50% MSCI AC World Net Total Return EUR + 35% Bloomberg Global Aggregate Index Total Return EUR-Hedged + 15% Bloomberg EUR Corporate Total Return 1-3 Year is solely used for the purpose of the fulcrum adjustment.

The Sub-fund qualifies as Article 6 of SFDR Regulation.

You may request the redemption of your units on a daily basis.

Dividends are not intended to be distributed. Any income derived from the product is reinvested.

Intended retail investor: The Sub-fund is intended to be marketed to professional investors and retail investors who are able and willing to invest in a Sub-fund actively managing the allocation between equities and bonds, with a medium risk grading and to a get a return over 5 years.



We have classified this product as 3 out of 7, which is a medium-low risk class. This classification rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

### What happens if Azimut Investments S.A. is unable to pay out?

The assets of the product are held in safekeeping by BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of Azimut Investments S.A. (the "Management Company"), the product's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the product may suffer a financial loss. # What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year, you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 10,000 is invested.

### How long should I hold it and can I take money out early?

#### Recommended holding period: 5 years

The recommended holding period has been defined by taking into account the expected composition of the Sub-fund's portfolio, as well as long-term averages of return and risk for relevant asset classes and markets.

You may request the redemption of your units on a daily basis. You may receive less than expected if you cash in earlier than the recommended holding period. The recommended holding period is an estimate and must not be taken as a guarantee or an indication of future performance, return or risk levels.

Holders of units may request redemption at any time. Redemption will be performed by the Custodian within five bank business days following calculation of the applicable net asset value.
