What is this product?

Type: The Fund is a mutual investment fund qualifying as an undertaking for collective investment in transferable securities (UCITS) established under Luxembourg law.

Term: This product has no specific maturity date.

Azimut Investments S.A. is entitled to terminate the contract unilaterally.

Azimut Investments S.A. may terminate the contract unilaterally inter alia in case of liquidation or merger of the Sub-fund. Please refer to the prospectus for additional informations on early termination circumstances.

Objectives

The Sub-fund is Feeder of the "AZ Fund 3 - AZ Bond - Frontier Markets Debt" Sub-fund (the Master). The Feeder shall permanently invest at least 85% of its assets in the MASTER (USD) class of said Master. The objective, investment policy and risk profile of the Feeder and the Master are similar.

The Master's investment objective is to achieve long-term capital growth by actively investing, directly and/or indirectly (through debt securities classed as "Global Depositary Notes" (GDN)), at least 60% of its net assetsin a diversified portfolio of debt securities issued by governments, supranational institutions and governmental authorities of frontier market countries.

The securities in which the Master invests are traded on both local frontier markets (provided that they are classified as regulated markets) and international regulated markets.

Frontier market issuers are generally rated as sub-investment grade by rating agencies. Less frequently, they are graded as distressed, i.e. CCC+ (or the alphanumeric equivalent) or lower. Consequently, the Master may invest up to 100% of its net assets in debt securities with a sub-investment grade rating, up to 20% of its net assets in distressed securities (including defaulted securities) and up to 15% of its net assets in defaulted securities.

The Master may also invest up to 10% of its net assets in debt securities and money market instruments issued by governments, supranational institutions or governmental authorities of emerging countries that are not classified as frontier market countries.

The Master's prospectus provides that, in exceptionally unfavourable market conditions (such as the 9/11 attacks or the collapse of Lehman Brothers in 2008), on a temporary basis and for as long as is strictly necessary, the Sub-fund may invest up to 100% of its net assets in cash, bank deposits and/or money market instruments, if justified by the interests of investors.

The Sub-fund uses the main derivative financial instruments for investment purposes in order to implement its investment policy and/or for hedging purposes. The Sub-fund aims to keep overall risk below 100% calculated according to the commitment method.

The Sub-fund is actively managed. The 3-month Libor USD + 2.5% is solely used for the purpose of calculating the fulcrum adjustment.

The Sub-fund qualifies as Article 6 of SFDR Regulation.

You may request the redemption of your units on a daily basis.

Dividends are not intended to be distributed. Any income derived from the product is reinvested.

Intended retail investor: The Sub-fund is intended to be marketed to professional investors and retail investors who are able and willing to invest in an emerging market fixed-income-focused Sub-fund, with a high risk grading and to a get a return over 7 years.



What are the risks and what could I get in return?



We have classified this product as 4 out of 7, which is a medium risk class. This classification rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

As you may receive payments in the currency of this product and not that of your country, the final return you will get will depend on the exchange rate between these two currencies. What happens if Azimut Investments S.A. is unable to pay out?

The assets of the product are held in safekeeping by BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of Azimut Investments S.A. (the "Management Company"), the product's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the product may suffer a financial loss. This risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the product. The Depositary will also be liable to the product and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). There is no investor compensation or guarantee scheme in the case of default of the Management Company or the Depositary.

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year, you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The recommended holding period has been defined by taking into account the expected composition of the Sub-fund's portfolio, as well as long-term averages of return and risk for relevant asset classes and markets.

You may request the redemption of your units on a daily basis. You may receive less than expected if you cash in earlier than the recommended holding period. The recommended holding period is an estimate and must not be taken as a guarantee or an indication of future performance, return or risk levels.

Holders of units may request redemption at any time. Redemption will be performed by the Custodian within five bank business days following calculation of the applicable net asset value.
