What is this product?

This product is a sub-fund of the fund BL constituted in the form of an investment company with variable capital with multiple sub-funds under Luxembourg law, subject to Part I of the Luxembourg law of December 17, 2010 concerning undertakings for collective investment.

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

Seeking a capital gain. This mixed sub-fund invests a minimum of two-thirds of its net assets in shares. debt instruments and money market instruments of issuers based in or exercis-

ing a dominant portion of their activities in emerging countries. The sub-fund invests more than 60% and up to 100% of its net assets in shares at all times.

In order to achieve its objective, the sub-fund may invest a maximum of 10% of its net assets in open-ended investment funds.

In addition, the sub-fund may invest in debt instruments issued or guaranteed by a state or international public bodies other than emerging countries.

The sub-fund may also make use of derivative products for hedging purposes or to optimise the portfolio's exposure. The investment manager integrates and promotes sustainability factors within

his equity investment strategy by applying non-financial data to the issuer val-uation model. In terms of bond investments, the investment manager will pay particular attention to ESG criteria by performing an ESG rating of the various issuers based on qualitative and quantitative criteria.

Investments are made without any geographical, sector-based or monetary restrictions.

The investments will be mainly made in securities issued in USD, local currencies or EUR. In principle, the foreign-exchange risk is not hedged. However, in exceptional cases and depending on the valuation outlook, certain currencies may be hedged.

Bonds and other equivalent securities may be issued or guaranteed by companies, states or other entities

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a long time period. The investor may experience losses up to the amount invested. This product is suited to investors with a detailed to in-depth knowledge and experience of the product and the emerging equity markets.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The in-vestor can obtain information about how to convert in the prospectus of the fund.

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. What happens if BL is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
