What is this product?

Type

This product is a sub-fund of the fund BL constituted in the form of an investment company with variable capital with multiple sub-funds under Luxembourg law, subject to Part I of the Luxembourg law of December 17, 2010 concerning undertakings for collective investment.

Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

Seeking a long-term capital gain.

The sub-fund invests at least 75% of its net assets in shares of companies that are either based in emerging markets or carry out a major part of their business activities in those markets.

A maximum of 10% of the net assets may be invested in open-ended investment funds.

The sub-fund may also use derivative products for hedging purposes or in order to optimise the portfolio's exposure. The investments are mainly made in securities issued in USD, local currencies or EUR.

The investment manager integrates and promotes sustainability factors within his investment strategy by applying non-financial data to the issuer valuation model.

The companies are chosen on the basis of their intrinsic quality and their valuation.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a long time period. The investor may experience losses up to the

amount invested. This product is suited to investors with a detailed to in-depth knowledge and experience of the product and the emerging equity markets. This product is eligible for retail investors under a remunerated management or advice mandate entrusted to a credit establishment or investment company by the investor. The conditions of eligibility for this product are described in the prospectus.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a distribution class meaning that income may be distributed.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

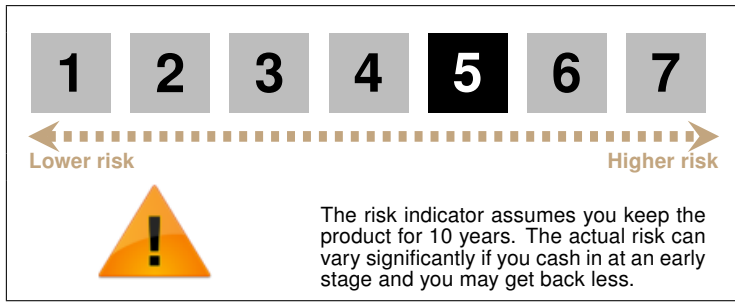

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Unfavourable scenario: This type of scenario occurred for an investment be-

tween October 2012 and October 2022, by referring to a benchmark.

Moderate scenario: This type of scenario occurred for an investment between July 2009 and July 2019, by referring to a benchmark.

Favourable scenario: This type of scenario occurred for an investment between August 2009 and August 2019, by referring to a benchmark.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if BL is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- 10,000 USD is invested

Recommended holding period: 10 years
