## WHAT IS THIS PRODUCT?

### Type

This Product is an undertaking for collective investment in transferable securities (UCITS). It is established as a sub-fund of BNP PARIBAS COMFORT, a FCP (fonds commun de placement- mutual investment fund), governed by the provisions of Part I of the Luxembourg Law of 17 December 2010 (the "2010 Law") relating to undertakings for collective investment as well as by Directive 2009/65.

### Term

This Product has no maturity date.

BNPP AM Luxembourg is entitled to dissolve the Product unilaterally. Dissolution may also take place in the event of a merger, total redemption of the units or when the net assets of the Product are less than the minimum regulatory amount.

### Objectives

The Fund belongs to the category of funds of funds. The Fund seeks to increase the value of its assets over the medium term by primarily investing in capitalisation shares of funds focused on the fixed income market.

The Fund is actively managed and as such may invest in instruments that are not included in the index, which is 30% Cash Index Euro Short Term Rate (EUR) RI 365 Days + 5% JPM EMBI Global (USD) RI + 60% Bloomberg Euro Aggregate 500MM (EUR) RI + 5% Bloomberg Euro Aggregate High Yield ex-Financials 3% Issuer Constraint (EUR) RI.

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

### Intended retail investors

This Product is designed for investors who have neither financial expertise nor any specific knowledge to understand the Product but nevertheless may bear a total capital loss. It is suited for clients who seek growth of and/or income from capital. Potential investors should have an investment horizon of at least 3 years.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk Indicator



The risk indicator assumes you keep the Product for 3 years.

The summary risk indicator is a guide to the level of risk of this Product compared to other Products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 2 out of 7, which is a low risk class. The risk category is justified by the investment mainly in interest rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.

**Be aware of currency risk.** If the currency of your account is different from the currency of this Product, the payments you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## WHAT HAPPENS IF BNPP AM LUXEMBOURG IS UNABLE TO PAY OUT?

The FCP is an undivided collection of transferable securities and / or other liquid financial assets distinct from BNPP AM Luxembourg. In the event BNPP AM Luxembourg would default, the assets of the Product/FCP, held by a depository, would not be affected by this default. In case of default of the depository, the risk of financial loss of the Product/FCP is mitigated by the legal segregation of the assets of the depository from those of the Product/FCP.

## WHAT ARE THE COSTS?

### Costs over time
