### Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by companies that operate in environmental markets and comply with United Nations recommendations in terms of social and environmental responsibility, and corporate governance.


It may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license granted by the Chinese authorities.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI World Small Cap (NR)

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

#### Risk and Reward Profile

- Why is the Fund in this specific category?

The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Risks related to Shanghai Hong Kong Stock Connect: This risk relates to securities trading and clearing through the Stock Connect. Stock Connect is subject to quota limitation which may restrict the fund's ability to invest in China A-Shares on a timely basis. In addition, the Stock Connect is novel in nature, the regulations are untested and there is no certainty as to how they will be applied, which may affect the fund's ability to enforce its rights and interests in the China A-Shares.


