
Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by companies operating in the technology sector and/or in related sectors.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI World Information Technology 10/40 (NR). Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.


