Objectives and investment policy


The Fund is actively managed. The benchmark J.P. Morgan Asia Credit Non-Investment Grade is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.

The Fund seeks to increase the value of its assets over the medium term by investing in high-yield bonds issued by Asian companies or companies operating in Asia. The Fund may be invested into bonds traded on the China Interbank Bond market.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

Risk and reward profile

- Why is the Fund in this specific category?
 The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk:</u> This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Operational and Custody Risk</u>: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- Risk related to investments in Mainland China: such investments are subject to additional risks that may be the result of political, economic, social, tax, market and operational factors specific to the Chinese Market.
