### Objectives and Investment Policy

The Fund is an index-tracking passively managed fund.


The Fund seeks to replicate (with a maximum tracking error\* of 1%) the performance of the BNP Paribas Energy & Metals Enhanced Roll (TR) (the «Index») by investing in a substitute basket, composed of, inter alia, shares of companies, debt securities or cash (synthetic replication).

When investing in a basket of securities called substitute basket the performance is swapped with the performance of the index, generating counterparty risk.

\*The tracking error is a risk indicator that measures how closely a fund tracks the performance of its reference index. Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

# Risk and Reward Profile



- · Historical data may not be reliable indication for the future.
- The risk category of a Fund is an indicator but not a target or a guarantee and may shift over time.

- Why is the Fund in this specific category?
  - The risk category is justified by the investment in Commodity markets that may experience significant, sudden price variations. Thus, the underlying assets may evolve in a markedly different way from traditional securities markets (share markets, bond markets etc).
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Counterparty Risk:</u> This risk is associated with the ability of a counterparty in an
  Over The Counter financial transaction to fulfil its commitments like payment,
  delivery and reimbursement.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.


